Meeting was called by John K. Simons, Water & Sewer Commissioner for purpose of making plans toward Disposal Plant.

Members present were James E. Culver, John K. Simons, Earl C. Willey, Daniel L. Short and Donald L. Melson.

Present from the Advisory Board were John Hopkins, Ira Lewis, Richard Harris, Edwin Layton, Thurman Adams, Jr. and Allan Jones.

Mr. Simons explained the present and future plans of the sewers in town, what we had and what was needed for the future. Plans for dividing the town in areas showing where lines are now and where they will be needed most were discussed.

Information from this meeting was sent to Gardner & Sterling, Engineers as in letter below:

Gentlemen,

Thank you very much for your suggestions on plan of action concerning our proposed disposal unit.

Per your suggestion, the Bridgeville Pollution Commission held a meeting Tuesday evening, August 18 to ascertain just what we thought we would want or need in the way of sewers, Etc.

Our meeting lasted sometime over two hours and we came up with the following items and gave each a priority for sanitary sewers:

1. Elliott's Drive, Jacob and South Cannon Streets.
2. First Street.
3. Second Street and North Cannon beyond the Branch.
4. Elm Street and Sussex Street immediately north of Laws St.

We gave priority to the streets that could most afford to pay for sewer in that order. Of course, if industry cares to come in with the town, they will get first priority over all others.

In going over the maps we have, we find that the 1952 proposal is rather hard to follow and explain. We wonder if it would not be better to have separate maps for the present combined sewers, proposed sanitary sewers according to priorities, and storm sewers. The maps of the proposed storm sewers and drains are alright excepting for the changes made by the State and the town board. I can give you these changes when you are in town on the twenty fifth.
