This is from the Water & Air Resources Commission and signed by Mr. John C. Bryson, Executive Director. After much discussion, it was decided to proceed as directed in the above certificate.


Mr. Willey was instructed by President Simons to look into the cost of having city trash collection.

Mr. Paul Lynch began discussion concerning the operation of the grease removal pit at the Ralph & Paul Adams Plant. Mr. Lynch stated that Mr. Harry Hammond and Mr. Jesse Williams, disposal plant operators, claim that the pit isn't being watched and maintained properly by Ralph & Paul Adams. President Simons said he would look into the matter.

Mr. Paul Lynch began discussion concerning the matter of recovering the money from the expense it cost the town to install the grease removal pit at Ralph & Paul Adams, Inc. After some discussion, President Simons, is to talk with the owners of Ralph & Paul Adams, Inc. and try to arrange some kind of agreement for settlement of the above mentioned expenses.

COMMISSIONERS OF BRIDGEVILLE

OCTOBER 9, 1968

Meeting called to order by President Simons at 8:00 P.M.  
Other Commissioners present were Paul Lynch, Earl Willey,  
T. J. Gray, Jr. and G. F. Hardesty, Jr.

Other persons present were as follows:

1. Dr. N. C. Vasuki, Asst. Director of Water & Air Resources State of Delaware.
2. Mr. William Sabis, from the State Pollution Dept.
3. Mr. Dean Betts, Attorney, Georgetown, Del. - Bridgeville Solicitor.
4. Mr. Harry Hammond, Supt. Bridgeville Disposal Plant.

The purpose of this meeting was to discuss the problems so to have the Disposal Plant certified by the State, and therefore for the Town of Bridgeville to receive the last 10% of the Federal and State funds toward plant construction cost.

Dr. Vasuki began discussion stating, 1. That the Disposal Plant is being by-passed from time to time without notifying the State; 2. That H. P. Cannon & Son Co., Inc. and Dulany Foods, Inc. are dumping excessive amounts into the Disposal Plant. Also the flow meters at these two location were working but not correctly.

Mr. Wm. Sabis stated; 1. He thought the flow meters were operating and flow reading indicated was fairly accurate. He stated some arrangement should be made to control or reduce the flow coming into the plant. 2. That the grease problem at Ralph & Paul Adams, Inc. has been satisfactorily taken care of.

Dr. Vasuki further stated that the Disposal Plant was designed to handle from H. P. Cannon & Son Co., Inc. 1,000 parts B.O.D. and on September 24, 1968 it has checked at 1,500. The B.O.D. estimate to handle from Dulany Foods is 450 parts.

Mr. Richard Harris asked Dr. Vasuki how to reduce the B.O.D. Dr. Vasuki stated that they would have ~~me~~ to be balance fed by various amount on nitrogen at the Disposal Plant intake. Mr. Sabis stated if this was done properly it should correct the B.O.D. high count and also prevent ordors. Dr. Vasuki stated

that B.O.D. samples should be taken daily at each plant and this would help determin the B.O.D. problem.

Mr. Sabis stated that the plants could reduce their flow to the Disposal Plant but the problem of main concern is the high B.O.D. count. Dr. Vasuki stated the B.O.D. could be treated at the two plants. After some discussion it was decided it would be more economical to pump it to their field, H. P. Cannon & Son Co., Inc.


It was decided that Dr. Vasuki will inspect the flow meters at the two plants in the near future. If he finds them insufficient, he will write President Simons concerning the problem. President Simons then will present this to Mr. Dean Betts who in turn will contact the engineers, *GARDNER* ~~Perry~~ & Sterling in Salisbury, Maryland to correct the problem.

This will help decide how much the two plants will be required to reduce their flow as orginally agreed. (H. P. Cannon & Son, 250,000 gallon flow per day and Dulany Foods, Inc. 560,000 gallons per day flow.)

The next step is then to determine the B.O.D. problem and take care of this. It was decided if this doesn't solve the overall problems, the Disposal Plant itself will have to be redesigned to adjust to the B.O.D. and flow rates.

E. Willey made a motion to hire G. Torbert, the Town Alderman, at \$100.00 per week. T. J. Gray, Jr. seconded motion and approved by the floor.

President Simons, discussed haveing the Town Lawyer, Mr. Dean Betts, meet with the Commissioners to talk about the Town Alderman's office. Also to review and make any necessary changes in the Town Charter. This is to be completed and ready for State Legislature by January 1969. Paul Lynch made a motion to retain Tunnell and Raser, attorneys of Georgetown, Delaware to act as Town Solicitor, if Mr. Betts cannot help in the near future. Motion seconded by Earl Willey and approved by floor.

Earl Willey made a motion to pay \$4,000.00 toward Contract No. 1596 for drainage of Laws Street in 1956 and 1957. Motion seconded by Paul Lynch and approved by floor. This will leave a balance of \$11,000.00.

President Simons discussed the money still due the Town of Bridgeville, as described in the minutes of August 8, 1968. President Simons, stated that Mr. Sabis, of the State Pollution Department has inspected the Disposal Plant and found everything satisfactory. However, Dr. N. C. Vasuki, Assistant Director of the State Water and Air Resources Commission, has failed to see that the town receives the \$21,000.00 due from the State and \$35,500.00 due from the U. S. Government. President Simons said he solicited the assistance from Mr. Arno Loessner of the State Planning Office. President Simons has recently received a letter from Mr. Loessner, stating the town should receive the funds within three weeks. (STATE FUNDS ONLY AS YET)

Paul Lynch made a motion to send Mr. Harry Hammond, Disposal Plant Manger, to a four day school in Baltimore, Maryland to held with his training. Motion seconded by Earl Willey and approved by the floor.

Earl Willey stated the Town Dump has been on fire the last few days. The fire Company has brought the fire under control but it is still burning. Mr. Willey reported he has had dirt spread over the area.

Meeting called to order at 8 P. M. by President, J. K. Simons. Members present were Paul Lynch, Earl Willey and George F. Hardesty, Jr.

Other persons present were Mr. & Mrs. Ronald Spriggs, owners of Tiny's restaurant on Market Street. Also present were Police Officer, Virgil L. Kinder and Police Chief Frank T. Galante.

Purpose of the meeting was to discuss the robbery of \$18.00 in bills and change from Tiny's Restaurant early this morning.

The robbery was discovered by Mrs. Spriggs at 6 A. M. She said the rear door was open and the front door was locked. She also stated that she locked the front door at 10 P. M. 8/21/68 and left the building by the rear door and locked it from the outside. Mrs. called the State Police who in turned called Officer Kinder of the town police, at 6:10 A.M.

Police Chief Galante stated he checked the front door at 12:27 A. M. 8/22/68 and found it unlocked. He further stated he entered the front door, checked the building and back door and found everything alright. He placed his signed night slip marked O. K. and left the building by the front door. Chief Galante stated he would have informed the Owner but did not know his name or address.

Mr. & Mrs. Spriggs could not understand why the night check slip was marked O. K. since the door was found open and 18.00 was gone.

After much discussion, it was suggested that the restaurant was broken into after Chief's Galantes inspection.

President Simons instructed Chief Galante to obtain the name address and phone number of the owner and for the Police Dept. to maintain and up to date list of names and telephone numbers of all businesses in Bridgeville, to have in case of an emergency. Chief Galante was also instructed not to enter any unlocked building until the owner is present and can enter with the police.

President Simons stated his reasons was for the safety of the policeman, also the Policeman could not be put on the spot.

AUGUST 28, 1968

President Simons called the meeting to order at 8 P. M. Members present were Mr. Paul Lynch, Mr. Earl Willey, Mr. T. J. Gray, Jr. and Mr. G. F. Hardesty, Jr.

The purpose of this special meeting was to discuss the Town Alderman's Office. It has been brought to the attention of President Simons, by Mr. William Lee, assistant Attorney General for the State of Delaware, thru Mr. Riley, an Inspector from the State Attorney's Office, that the Town of Bridgeville can only have one Town Alderman according to the Town Charter.

He further stated that until Mr. Torbert is relieved of his position as Town Alderman; that he is still the Town Alderman. This was brought to the attention of the State Attorney General's office by Mr. Bramhall, Attorney at Law, of Georgetown, Delaware, who is representing Mr. Carlton Banks.

Our acting assistance to the town alderman is Mrs Neva McClary who was elected by the Commissioners on July 7, 1968 and is recorded in the town minutes as such. The Commissioners took the above action as set forth in paragraph three (3) of Section six (6) of the Bridgeville Town Charter. Mr. Carlton Banks was recently taken before Mrs. McClary by the Bridgeville Police for beating his wife. In lieu of the lack of funds for his fine, Mrs. McClary sentenced Mr. Banks to be confined in the Sussex County Correctional Center for a period of 100 days.

The Town Commissioners had previously had Mr. Harry Helm act as an assistant Town Alderman for two years (2) until he resigned in January of 1968. The Commissioners have been trying to get an assistant town alderman until Mrs. McClary was elected.

After much discussion, and since the Town's Attorney, Mr. Dean Betts is away thru September 9, 1968, President Simons appointed Mr. Paul Lynch to see Mr. Edward Maull an Attorney, of Georgetown Dela., to-morrow to give us a ruling concerning the Assistant Town Alderman's Status. Mr. Lynch is to report to the Commissioner -s as soon as possible.

President Simons instructed Commissioner T. J. Gray, Jr. to inform all Bridgeville Police to take all cases to Dela. State Court No. 4 in Seaford, Dela. until further notice.

Mr. Paul Lynch made a motion to have the water stand pipe repainted. Work to be done by Dominion Tank and Iron Co. of Petersburg, Va. Total cost will be \$1,068.00 Motion seconded by Mr. Earl Willey and approved by floor. This is continuation of orginial contract by the above named company, in order to keep their guarante good. Meeting adjourned at 9:20 P. M.



Meeting called to order by President Jack Simons at 9:15 PM. Members present were T. J. Gray, Jr., Earl Willey, and G. F. Hardesty, Jr.

President Simons read the following proposed ordinance: "An ordinance authorizing the establishing by the President of Commissioners or Chief of Police of the Town of Bridgeville of certain emergency measures and prescribing penalties for violations thereof." After much discussion, T. J. Gray, Jr. made a motion to accept the ordinance as read by President Simons. Motion seconded by Earl Willey and passed by floor.

President Simons read the following proposed ordinance: "An ordinance declaring loitering and lounging on streets, street corners, pavements, sidewalks or crossing which obstructs pedestrian traffic to be unlawful, prescribing penalties thereof, and repealing any inconsistent ordinance." After some discussion, Earl Willey made a motion to accept the ordinance as read by President Simons. T. J. Gray, Jr. seconded the motion and passed by the floor.

President Simons announced that the radar unit was not purchased because offenders have to be taken to magistrate court for trial, or to a town alderman that is on a salary by the town. Also the amount authorized to spend for the radar unit was \$40.00 more than approved by the commissioners.

T. J. Gray, jr. stated that he would like to have a fourth policeman on duty for the coming thirteen summer weekends. He further stated that Mr. Franklin Almond Fountain, of RD 3, Box 48B, North St., Extd., Milford, Delaware was the only acceptable applicant for the job. Mr. Gray said he talked with the reference Mr. Fountain gave him. Mr. Fountain is employed by the Milford School District as a janitor and also is a special constable for Kent County. Mr. Gray made a motion to hire Mr. Fountain for the position of patrolman at \$50.00 per weekend tour, Friday, Saturday and Sunday. Motion seconded by Earl Willey and approved by floor with one not voting.

Mr. T. J. Gray, Jr. began discussion concerning hiring and assisting Town Alderman. Mr. Harry Helm had quite this position in January of this year. Mr. Torbert will be going away soon on vacation and the town should have an assistant alderman available. Mr. Gray stated he has approached a number of persons to take the job, but with no success. However, he stated that Mr. John Horner of 16 Church St. said he would accept the job. Mr. Gray made a motion to hire Mr. Horner for assistant Town Alderman. Motion seconded by Earl Willey and approved by floor.



over 100,001 Gals. - 15¢

The above motion seconded by Earl Willey and approved unanimously.

Earl Willey made a motion to reduce the assessment rate for 1968-69 by 10¢ and to be set at 75¢. Motion seconded by Paul Lynch and approved unanimously.

Earl Willey made a motion to hold the sewer rate at the present 60¢. Motion seconded by Paul Lynch and approved unanimously.

Earl Willey made a motion to purchase a picture from Scott's Furniture, Inc. at \$23.95 to be hung in the main entrance of the Town Office Building. Motion seconded by George Hardesty, Jr. and approved unanimously.


President Simons announced that he would put all the figures together from all the departments and have them available for approval of the 1968-69 budget at the next meeting.

SPECIAL MEETING

President Jack Simons called this special meeting to order at 8:00 PM with all the commissioners present. Also in attendance was Mr. Wm. Sabis, State Pollution Department, Mr. Wm. Lloyd, Sussex County Board of Pollution & Air Resources, and Dr. N. C. Vasuki, Asst. Director of Water & Air Resources Commission, State of Delaware.


Mr. Sabis sited the average flow for several months of 1967. He stated that the plant is designed to handle approximately 1,000,000 gallons per 24 hours. In September, the flow reached 3.6 millions gallons with an average flow of 1.5 million gallons. In October the flow reached 3.2 million gallons with an average flow of 1.5 million gallons. In November the flow reached 2.6 million gallons. In November the flow reached 2.6 million gallons with an average of 1.2 million gallons. Because this overflow exist at various times, the bacteriae rate down stream rises.

It appears that the H. P. Cannon Co., Inc. & Dulany, Foods, Inc. are putting much more into the town system than they originally agreed. Cannon estimated they would put 250,000 gallons maximum flow per day into the town system. Duland Foods estimated they would put 560,000 gallons maximum flow per day into the town system.

Dr. N. C. Vasuki stated he would forward to the commissioners, a letter proposing what action should be taken to help stop these problems.

SPECIAL MEETING  
COMMISSIONERS OF BRIDGEVILLE  
JANUARY 23, 1968

This was a joint meeting with the Bridgeville-Greenwood Consolidated School Board. The meeting was held at the Bridgeville Central School and was called to order by the School Board President Mr. Paul O'Bier at 7:45 P.M.

The purpose of this meeting was to discuss some of the problems concerning water and sewerage for the new Bridgeville-Greenwood Consolidated School to be built one mile west of the town limits from Church Street.

The Town commissioners present were: President J. Simons, E. Willey, T. G. Gray, Jr., P. Lynch and G. F. Hardesty, Jr.

Also in attendance were Mr. William Sabis, Delaware State Director of Water Pollution Control, and Mr. William M. Lloyd, Sussex County Representative of Water and Air Resources.

The School Board asked Mr. Sabis, Mr. Lloyd and the commissioners several questions concerning the subject. President Simons and Mr. E. Willey answered the questions pertaining to the Town of Bridgeville. President Simons further stated that before the commissioners could offer any concrete decision and statements; the school board would first have to obtain the facts and figures concerning the following:


1. The Volumn of sewerage expelled? To answer this correctly, once the amount of sewerage was determined, the town engineer and the State Pollution Department would have to approve our existing sewer lines are large enough and if the sewerage plant can properly treat the additional sewerage.
2. The volumn of water needed? To answer this correctly it would be up to the State Fire Marshall Office, the State Board of Education and their engineers; then the town's engineer and water commissioner would have to check this information.

Mr. Sabis further stated that if the construction of a sewerage treatment plant be the school board's decision; it would meant an initial cost between \$30,000.00 and \$50,000.00 plus an annual cost of approximately \$8,000.00 to maintain it and pay a certified operator. Also the plant would be subject to state and federal regulations and would be inspected from time to time. Mr. Sabis furthers aid that he estimated if the school board wanted to install their own water system, stand tank, pumps, and etc.; that the cost would be between \$40,000.00 and \$60,000.00 for this. This system would also have to be maintained. He offered no estimate concerning this cost.

President Simons also stated that on behalf of the commissioners of Bridgeville, he hoped that the problems can be solved so the Town of Bridgeville can furnish the new school with water and sewer.

The Town Commissioners were then dismissed at 8:30 PM. with the understanding that the school board was to obtain the necessary facts and figures to further discuss the matter.
