ORDINANCE NO.: A13-2

AN ORDINANCE TO AMEND ORDINANCE A.12-2 RELATING TO VIOLATIONS AND PENALTIES BY REENACTING CERTAIN PROVISIONS OF THE BRIDGEVILLE CODE

WHEREAS, the Commissioners of Bridgeville have all powers granted to municipal corporations and to cities by the Constitution and general law of the State of Delaware, including the implied powers necessary to carry into execution all the powers granted; and

WHEREAS, the Commissioners have, from time to time, ordained penalties for violations of the various provisions of the Bridgeville Code; and

WHEREAS, the Commissioners on 9th of April, 2012, adopted Ordinance No. A12-2, entitled **AN ORDINANCE TO AMEND BRIDGEVILLE CODE RELATING TO VIOLATIONS AND PENALTIES** for the purpose of providing uniformity of the penalties for violations into one chapter providing for the payment of fines to the Town in lieu of court appearance, while preserving the right to administratively or judicially challenge any alleged violation is appropriate for the ease of administration and enforcement of such ordinances that may contain penalties for their violation; and

WHEREAS, it is the intention of the Commissioners to correct errors and to reenact certain provisions of the Bridgeville Code which were repealed by Ordinance No. A12-2, adopted on the 9th day of April, 2012.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSIONERS OF BRIDGEVILLE, to read as follows:

Section 1. Amend Ordinance No. A12-2, adopted April 9, 2012, entitled **AN ORDINANCE TO AMEND BRIDGEVILLE CODE RELATING TO VIOLATIONS AND PENALTIES** by deleting those portions ~~striken-through~~ and adding those portions underlined, as follows:

Section 1. Amend the Bridgeville Code by repealing the following sections:

Any person violating any provision of this chapter, upon conviction thereof, shall pay such fines as set out in Chapter 1, General Provisions. Article II, Penalties.

Section 2. This ordinance shall become effective upon its adoption by a majority of the members elected to the Commissioners of Bridgeville.
