New Business- 2019 EM Fund Request- Bridgeville Volunteer Fire Company M 004-20

Town Manager Savage stated that the Town has \$26,666.31 from building permits and he informed the Bridgeville Fire Company that money was available. Mr. Savage stated that the Bridgeville Fire Company submitted a grant request for this money to be used towards 14 complete sets of firefighter turnout gear.

A motion was made by Commissioner Smith and seconded by Commissioner Banks, to approve the request for funds from the Bridgeville Vol. Fire Department. The donation amount will be \$26,666.31.

Introduction of Ordinances

Commissioner Smith introduced an Ordinance that would amend the Bridgeville Code to provide for notice of tort claims and for the defense and indemnification of town officers and employees.

Commissioner Yoder stated that he would like to discuss at the next workshop to identify potential areas where they could submit funding requests from the state bonds through the legislators.

Commissioner Smith stated that they have cleared the trees for the mini storage expansion.

Town Manager Savage stated that the Tull's have cleared out the old Russell property and will be building a spec home.
