GEORGE H. TORBERT WAS SWORN IN FOR A ONE YEAR TERM.

AN UPDATE OF THE STATUS OF SHORE BEST POULTRY WAS GIVEN BY PRESIDENT SLATER. THE COMMISSIONERS HAVE RECEIVED A LETTER THAT IT LOOKS THAT THEY HAVE MET ALL OF THE TOWNS DEMANDS. THE CORRESPONDANCE HAS BEEN SENT BACK AND FORTH FROM THEM TO DAVIS, BOWEN & FRIEDEL.

BILL LECATES FROM THE DELAWARE HOUSING AND COMMUNITY DEVELOPMENT WAS PRESENT AT THE MEETING TO TELL EVERYONE ABOUT MONEY AVAILABLE TO THE TOWN CITIZENS WHO QUALIFY FOR 3% MONEY FOR HOUSING IMPROVEMENTS. THE TOWN WILL BE WORKING ON THIS PROJECT IN THE UPCOMING MONTHS. A PUBLIC HEARING WILL ALSO BE HELD.

GLORIA SCHOGLOPH WAS PRESENT AT THE MEETING TO ASK THE COMMISSIONERS ABOUT THE WATER LINE THAT WAS TO BE INSTALLED ON JOHN STREET. PRESIDENT SLATER SAID THAT THE TOWN WENT OUT FOR BIDS AND THAT IT WOULD BE DISCUSSED AT THE NEXT PLANNING MEETING. GLORIA STATED THAT THE LINE WOULD BE NEEDED WITHIN THE NEXT MONTH.

TONY FROM THE BALTIMORE TRUST COMPANY GAVE A PRESENTATION ON THE DIFFERENT INTEREST RATES AND AVAILABILITY OF THE BANK. HE OFFERED ANY ASSISTENCE TO ANYONE OR THE TOWN WITH FINANCING.

POLICE COMMISSIONER CROCKETT GAVE COMPLIMENTS TO CHIEF ORR AND THE POLICE DEPARTMENT AFTER THE DRUG RAID AT THE LAVERTY LANES APARTMENTS. TWO WEAPONS AND EXCESS OF FIVE GRAMS OF CRACK COCAIN WERE CONFISCATED.
