

COMMISSIONERS OF BRIDGEVILLE
REGULAR MEETING
MARCH 9, 1992

Meeting was called to order at 7 P.M. by Pres. Slater.

Minutes of the last regular Commissioner's meeting were read for approval. A motion was made by Comm. Torbert and seconded by Comm. Crockett and approved by all to accept minute

Mrs. Chaffinch said there were mistakes made in the minutes. Comm. Torbert asked her what changes needed to be made. She said the transcript was incomplete. It did not contain her motion for a meeting in two months and a referendum in six months for the right to vote issue.

President Slater called for the approval of bills. Motion was made by Comm. Torbert, seconded by Comm. Rizzo to pay all bills as presented. Motion carried.

Approval of the budget was called for by Pres. Slater. Motion was made by Comm. Rizzo to approve the 1992 budget, seconded by Comm. Crockett and approved unanimously. Copies of the Budget will be available to the public at a later date.

Several hauler's permits were submitted for approval. Permits were granted to Ace Septic Haulers and Johnson's Sewer & Drain Contractors to deposit domestic waste only. Grab samples will be taken for the next six months. This motion was made by Comm. Rizzo and seconded by Comm. Royal. Motion carried.

Comm. Royal said he would like to make an amendment to the minutes of the last meeting that he had read. He had omitted a page that talked about a bike race to benefit St. Jude's hospital and headed by Steve Heder.

Pres. Slater called on Hans Medlarz of Davis, Bowen and Friedel, Inc. After Hans presentation and discussions with the Commissioners about a revised permit with Rapa and any other industries a motion was made by Comm. Rizzo to issue a permit to Rapa with a 90 day comment period excluding the user's fee to be maintained as is subject to change. Motion seconded by Comm. Royal. A motion was also made by Comm. Rizzo to give authorization to Davis, Bowen and Friedel, Hans acting as their agent, to submit the annual report to DNREC as submitted to us by Davis, Bowen and Friedel; to make our Waste Water Treatment Plant evaluation report available to our industrial waste water users and to apply to amend our N.P.D.S. permit to allow us to chlorinate and dechlorinate; to rewrite the rules and regulations for the Environmental Protection Agency. Motion was seconded by Comm. Torbert. Motion carried.

President asked Sussex Recovery if they had anything they wanted to say or ask. They said they were waiting for the Commissioner's decision on the old Police Station. Pres. Slater said that the Commissioners had not really come to a decision but had talked about it. He said the Town was willing to carry more money for them. If they could pay 25% down we would carry the balance at

one percent above the mortgage interest rate that they could receive and that they would negotiate the mortgage pay-off. They would carry \$21,000 if that would help. Sussex Recovery said it may do so.

President called for Commissioner's reports:

Street Commissioner Royal stated that as of this month he has started a new system in regards to enforcing trash removal, permits issued on building permits and any other violations. He said they will be enforced. The public parking lot across the street has been stripped and the cross walks on Market St. will be marked as soon as weather permits.

Water Commissioner Torbert said he had nothing to report as there had not been any problems.

Sewer Comm. Rizzo said he had been working on his budget, trying to come up with a balanced budget which could help us with Farmers Home Administration. He is also looking again at alternatives to in-stream discharges which eventually he hopes, to eliminate the need for a NPDS Permit. He told Mrs. Chaffinch in answer to her concerns, that the County is in the process of condemnation of the houses she had referred to on Route 404. The have been inspected and meet all criteria for comdenation.

Police Commissioners Crockett said there had been 274 traffic arrests, 35 criminal arrest, 72 complaints of which 70 has been cleared with 12 cases still active. He said he and the Chief were looking at more part-time police officers to give around-the-clock police protection this summer.

President Slater said a Public Hearing will be advertised in the paper for 4 editions for March 31st at 7 P.M. concerning the Right to Vote Issue. All persons will have the opportunity to be heard.

Citizens Privilege - Mrs. Barbara Chaffinch thanked the Commissione for setting up the meeting. She said that Dr. Myers had suggested that the Commissioners and those concerned to get together before meeting with the Town's people. She asked if they still planned to do so. Pres. Slater said he saw no need for it.

Mr. Daryl Tull asked if Greenwood had begun to pay their share of the expenses of the sewer plant since they are now discharging into our plant. Comm. Rizzo said they will be billed in the immediate future. Mr. Tull wanted to know if they were being monitored. Mr. Rizzo said he would see that they would be.

Mr. Tull also wanted to know who paid for the grab samples taken from the Private Haulers. Comm. Rizzo said the cost would be paid for by the haulers. Mr. Tull also wanted to know if the Commissioners could see if the IGA and other stores would mail their advertisements instead of putting out door to door. He said they were becoming a problem of littering the yards and side-walks. Comm. Rizzo also told Mr. Tull that all the haulers now have to sign tickets and turn them in to John Loscomb, Plant Mgr.

A motion to adjourn the meeting was made by Comm. Crockett and seconded by Comm. Rizzo. Motion carried.
