REGULAR MEETING
COMMISSIONERS OF B'VILLE

MEETING WAS CALLED TO ORDER AT 7:00PM BY PRES. HARDESTY WITH A SALUTE TO THE FLAG. COMMISSIONERS SIPPLE AND FLEMING WERE NOT IN ATTENDANCE.

MOTION WAS MADE BY COMM. SLATER TO DISPENSE WITH THE READING OF LAST MONTHS MINUTES AND APPROVE OF THE SAME. MOTION SECONDED BY COMM. TULL. MOTION SO CARRIED 3-0.

MOTION WAS MADE BY COMM. SLATER TO APPROVE AND PAY ALL BILLS PRESENTED. MOTION SECONDED BY COMM. TULL. MOTION SO CARRIED 3-0.

UNDER CORRESPONDENCE- ALL COMMISSIONERS RECEIVED A COPY OF A BOOKLET CONCERNING THE WINDFALL MONIES TO THE STATE AND THE PROGRAMS GOV. CARPER WISHES TO ESTABLISH WITH THE MONEY THROUGHOUT THE STATE.

PRES. HARDESTY RECEIVED A LETTER AND PRICE FROM DELDOT CONCERNING THE SIGNS FOR THE BRIDGEVILLE HISTORIC DISTRICT. SENATOR ADAMS WILL BE HELPING WITH THE COST OF THESE SIGNS AND THE STATE WILL BE ERECTING THEM AT A LATER DATE.

MR. GLENN MILES , CHAIRMAN FROM THE WALK-A-THON FOR THE KIWANIS CLUB GAVE A BRIEF PRESENTATION ON THE WALK AND WHAT IT WILL INVOLVE. IT WILL BE HELD ON MAY 20 FROM 9-12PM WITH ABOUT 60 WALKERS. THEY WOULD LIKE TO SET UP A REGISTRATION DESK AT THE TOWN HALL IF ALLOWED. PRES. HARDESTY STATED THAT THEY DID NOT HAVE A PROBLEM EXCEPT THE COMMISSIONERS FELT THAT THE REGISTRATION TABLE SHOULD BE ELSEWHERE SINCE THE WALKERS WOULD HAVE TO CROSS MAIN & MARKET TO GET THERE AND IT IS A HEAVILY CONGESTED INTERSECTION. MR. MILES FELT THAT THIS WAS A GOOD IDEA AND WOULD AGREE TO HAVE IT ELSEWHERE.

MOSQUITO SPRAYING TIME IS UPON US AGAIN AND THE DNREC DEPT OF FISH AND WILDLIFE NEED THE TOWN'S ENDORSEMENT TO SPRAY USING LOW FLYING AIRCRAFT. A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. TULL TO ALLOW THEM TO SPRAY FOR MOSQUITO CONTROL. MOTION SO CARRIED 3-0.

A MOTION WAS MADE BY COMM. SLATER TO ENTER INTO EXECUTIVE SESSION AT 7:15 TO DISCUSS THE BID FOR THE OLD POLICE STATION ON RAILROAD AVE. MOTION SECONDED BY COMM. TULL. MOTION SO CARRIED 3-0.

THE COMMISSIONERS CAME BACK INTO REGULAR SESSION AT 7:20PM WITH NO MOTIONS BEING MADE IN EXECUTIVE SESSION.

A MOTION WAS MADE BY COMM. SLATER TO REJECT THE BID FOR THE POLICE STATION. MOTION SECONDED BY COMM. TULL. MOTION SO CARRIED 3-0.

PRES. HARDESTY THEN CALLED FOR DEPARTMENT REPORTS.

AFTER SOME DISCUSSION, COMM. TULL STATED THAT SHE WOULD LOOK INTO THE ORDINANCES AND SEE WHAT CAN BE DONE.

ROBERT BEGOR OF SEAFORD WANTED TO KNOW THE REASON FOR THE REJECTION OF THE BID, SINCE HE AND HIS WIFE WERE THE PROSPECTIVE BUYERS. PRES. HARDESTY STATED THAT REASON THAT THE COMMISSIONER TURNED IT DOWN WAS BECAUSE THEY DO NOT WANT TO GET INTO THE MORTGAGE BUSINESS. THEY WANT TO SELL IT AND BE DONE WITH IT. HE ALSO STATED THAT IF THEY WANTED TO DISCUSS IT LATER ON, THAT THEY WOULD BE MORE THAN HAPPY TO SIT DOWN AND TALK WITH THEM.

A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. TULL TO ADJOURN AT 7:45PM.. MOTION SO CARRIED 3-0.
