

COMMISSIONER OF BRIDGEVILLE
 REGULAR MEETING
 MAY 9, 1994

MEETING WAS CALLED TO ORDER BY PRES. TULL AT 7:04 WITH THE SALUTE TO THE FLAG. ALL COMMISSIONERS OF BRIDGEVILLE WERE PRESENT.

GUESTS PRESENT : (SEE ATTACHED LIST)

MOTION WAS MADE BY COMM. HARDESTY AND SECONDED BY COMM. SIPPLE TO DISPENSE WITH THE READING OF LAST MONTHS MINUTES AND APPROVAL OF THE SAME. BEFORE THE MOTION WAS APPROVED, PRES TULL STATED THAT HE WOULD LIKE TO MAKE AN AMENDMENT TO THE MINUTES REGARDING THE RAPA AVERAGE QUARTERLY FLOW (MGDS \times SBOD ALLOCATION \times 8.34 #'s GALLONS \times DAYS IN QUARTER \times RATE PER NUMBER OF LOADS) IT SHOULD SAY NUMBER OF DAYS RAPA OPERATES INSTEAD OF DAYS IN THE QUARTER. MOTION WAS THEN SO CARRIED.

A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. TORBERT TO PAY BILLS AS PRESENTED. BILLS TOTALING \$31,824.81 FOR THE MONTH OF APRIL. MOTION APPROVED.

PRES. TULL STATED THAT HE HAD THE FIRST READING OF THE "ORDINANCE PROVIDING THE RULES AND REGULATIONS RELATING TO THE USE OF PUBLIC SEWERS, TOWN OF BRIDGEVILLE" THERE IS ONE MODIFICATION IN SECTION 2.7-SBOD ALLOCATION OF THE 52 PAGE ORDINANCE. THERE WILL BE A SECOND READING IN JUNE'S REGULAR MEETING.

PRES. TULL INFORMED THE COMMISSIONERS THAT THE TOWN SOLICITOR HAD GONE OVER THE EASEMENT AGREEMENTS BETWEEN CASE EDWARDS AND DELMARVA RURAL MINISTRIES AND FOUND THEM TO BE SATISFACTORY. THE TOWN NEEDS TO HAVE THE ORIGINAL COPY OF THE WATER EASEMENT FOR CASE EDWARDS BEFORE THEY CAN SIGN ANYTHING. A MOTION WAS MADE BY COMM. HARDESTY AND SECONDED BY COMM. TORBERT TO SIGN THE EASEMENTS BETWEEN CASE EDWARDS AND DELMARVA RURAL MINISTRIES. A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. HARDESTY THAT THE PRESIDENT AND THE SECRETARY OF THE COMMISSION SIGN THE SEWER EASEMENT AGREEMENT BETWEEN THE TWO ABOVE PARTIES. MOTION SO CARRIED.

PRES. TULL INTRODUCED CASE EDWARDS'S REPRESENTATIVE WHO WOULD LIKE TO BUILD 32 MORE UNITS ON THE EAST SIDE OF THEIR PRESENT PROJECT. THEY HAD HELD A PUBLIC HEARING ON MAY 2ND ON WHAT THEY HAD INTENDED TO BUILD AND TO ANSWER ANY QUESTIONS THAT THE PUBLIC MIGHT HAVE. PRES. TULL THEN STATED HE WOULD LIKE TO OPEN THE FLOOR TO ANY QUESTIONS THAT ANYONE MIGHT HAVE DURING CITIZEN'S PRIVILEGE.

PRES. TULL SAID THE DELAWARE GATEWAY PLAZA SEWER LINE HAS BEEN TABLED UNTIL JUNE'S REGULAR MEETING.

THE ACCOUNTING BIDS WERE DISCUSSED BY PRES. TULL AND THE COMMISSIONERS. A MOTION WAS MADE BY COMM. TORBERT AND SECONDED BY COMM. HARDESTY TO ACCEPT WADE AND SANTORA'S BID OF \$45.00 PER HOUR TO PERFORM THE ACCOUNTING SERVICES FOR THE TOWN. MOTION SO CARRIED.

BIDS FOR GRASS CUTTING WERE DISCUSSED. COMM. SLATER MADE A MOTION TO HIRE A PART-TIME MAINTENANCE PERSON AT \$5.00 PER HOUR NOT TO EXCEED 20 HOURS A WEEK. MOTION WAS SECONDED BY COMM. TORBERT. MOTION SO CARRIED.

PRES. TULL CALLED FOR DEPARTMENT REPORTS.

ALDERMAN REPORT-COPY ATTACHED.

POLICE DEPT. COPY ATTACHED. COMM. TORBERT SAID THAT SGT. OATES HAD RETURNED TO WORK PART-TIME AFTER HIS HEART SURGERY AND WAS RETURNING TO FULL DUTY ON MAY 14TH.

SEWER DEPT. COMM. SLATER STATED THAT EVERYTHING WAS GOING WELL.

STREET DEPT. COMM. SIPPLE SAID THAT THE STREET IN FRONT OF RAPA HAD BEEN REPAIRED AND THAT THE CLEAN-UP DAYS WENT LONGER THAN ANTICIPATED, THEY WORKED THRU FRIDAY GETTING ALL THE DEBRIS. THE CITY OF HARRINGTON HAD REPAIRED SOME OF THE POT HOLES AROUND TOWN AND WILL BE COMING BACK TO FINISH SOMETIME IN THE FUTURE WHEN WEATHER PERMITS.

WATER DEPT.- COPY ATTACHED

PRES. TULL STATED THAT A NEW REFUSE AND GARBAGE ORDINANCE AND A NEW BURNING ORDINANCE WILL BE WRITTEN AND PRESENTED FOR THE FIRST READING ON THE JUNE'S AGENDA. HE THANKED COMM. HARDESTY FOR ATTENDING THE B'VILLE HISTORICAL SOCIETY CEREMONY HELD ON SAT. MAY 7 DECLARING SOME OF THE AREAS OF THE TOWN HISTORICAL.

COMM. SIPPLE SAID THAT SHE BEEN IN CONTACT WITH DR. KINGREE OF THE WOODBRIDGE SCHOOL DISTRICT ABOUT PUTTING STORM DRAINS ON SCHOOL LANE. WATER FROM THE SCHOOL BUILDING HAS NO PLACE TO GO AND JUST SITS IN THE STREETS, SHE IS AWAITING A RESPONSE. SHE ALSO STATED THAT THE A STREET SWEEPER MAY BE COMING IN THIS SPRING TO CLEANUP THE STREETS.

CITIZENS PRIVILEGE- MS. LISA VOLK OF D.R.M GAVE A PRESENTATION ABOUT A MEDICAL CENTER BEING BUILT IN BRIDGEVILLE NEAR THE PROPOSED SITE OF ELIZABETH LANDING. IT WOULD HAVE MEDICAL OFFICES, DENTAL AND POSSIBLY A PHARMACY. PRES. TULL STATED THAT THE LAND WOULD HAVE TO BE REZONED AND A PUBLIC HEARING HELD BEFORE THIS COULD EVEN BE CONSIDERED.

THE ARCHITECT SHOWED HIS DESIGNS OF THE BUILDING. MS. VOLK ASKED IF THERE WERE ANY SITES IN TOWN THAT THEY COULD POSSIBLY RENT TEMPORARILY..

MR. JACK LEWIS OF 419 S. MAIN SPOKE OF THE TRUCK TRAFFIC COMING THRU TOWN.

MR AL RIZZO OF MARKET STREET QUESTIONS DELMARVA RURAL MINISTRIES ON WHETHER OR NOT THEY STILL PLANNED TO DONATE 5 ACRES OF THE LAND THAT THEY OWNED. MS. SINGLETARY SAID NO COMMITMENT HAD BEEN MADE.

COMM TORBERT ADDRESSED THE MEDICAL CENTER BY ASKING IF THEY WEREN'T DUPLICATING THE SERVICES OF THE STATE CENTER ALREADY LOCATED IN BRIDGEVILLE.? MS. VOLK SAID THAT THE ONLY MEDICAL SERVICE THAT THEY PROVIDE NOW IS 2HRS A MONTH OF IMMUNIZATION SHOTS.

PAM QUILLEN STATED THAT SHE KNOWS THAT THERE IS A NEED FOR SOMETHING LIKE THIS, BUT WHY COULDN'T THEY GO TO ANOTHER NEARBY COMMUNITY, BRIDGEVILLE HAS GOTTEN ITS SHARE OF HOUSING AND CENTERS.

MR. DAVE BOYD OF MAIN STREET SAID THAT HE DIDN'T WANT TO SEE ANYMORE LOW INCOME HOUSING COMING TO BRIDGEVILLE. WHY CAN'T WE(TOWN) GET REGULAR HOUSING FOR NEWLYWED PEOPLE, OR FOR PEOPLE WHO ARE JUST STARTING OUT?

JEFF SCOTT ASKED CASE EDWARDS IF THEY HAD DECIDED ON ERECTING A FENCE AROUND CANTERBURY TO KEEP THE TENANTS FROM CUTTING THRU TOWN RESIDENTS YARDS AND HOMES. THE CASE EDWARDS REP. STATED THAT THEY HAVE SURVEYED THIS PROBLEM AND FELT THAT IT WOULD BE BETTER TO PUT A FENCE UP BEHIND THE RESIDENTS PROPERTY THAT WERE AFFECTED RATHER THAT THE APARTMENTS.

MRS. CHARLOTTE CANNON WAS INTRODUCED AND WANTED TO DISCUSS THE TRUCK ROUTE THAT WAS SUPPOSED TO BE FINISHED BY 9/94. NOW SHE IS BEING TOLD BY DELDOT THAT THEY NEED TO RE-SURVEY AND IT MIGHT NOT GET DONE UNTIL 1995. SHE STRONGLY URGES THE COMMISSION TO CHAIR A COMMITTEE TO GO TO DELDOT AND DEMAND THAT THE TRUCK ROUTE BE DONE AS PLANNED, ESPECIALLY WITH THE UPCOMING REFERENDUM WORK TO SOON START HERE IN TOWN. MR. JACK LEWIS AND MR. RAYMOND SHORT VOLUNTEERED TO BE ON THE COMMITTEE TO PET THE PETITION. (COPY OF VOLUNTEERS ATTACHED) MRS. CANNON ALSO URGED THE COMMISSIONERS TO CONTACT THE REPRESENTATIVE AND THE SENATOR ABOUT THE URGENCY TO GET THE TRUCK ROUTE STARTED. PRES. TULL STATED THAT HE WOULD PUBLICIZE A MEETING NEXT WEEK. THIS WOULD BE A PUBLIC HEARING ON THE TRUCK ROUTE WHICH WILL BE ADVERTISED.

MRS. CAROL GAISOR STATED THAT APPLE-SCRAPPLE MEETINGS WOULD SOON BE STARING AND THAT SHE WOULD APPRECIATE ANY VOLUNTEERS TO HELP.

A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. TORBERT TO GO INTO AN EXECUTIVE SESSION TO DISCUSS PERSONNEL AT 8:55PM. MEETING WAS ADJOURNED.
