

REGULAR MEETING
MAY 11, 1992

MEETING CALLED TO ORDER BY PRESIDENT SLATER AT 7:00 P.M.

MINUTES FROM THE PREVIOUS MINUTES WERE READ BY COMMISSIONER ROYAL. MR. MEGEE WAS NOT PRESENT AT THE LAST MEETING. CHARLES WEST SPOKE ON BEHALF OF OPPOSING THE RIGHT TO VOTE. A MOTION WAS MADE BY COMM. TORBERT AND SECOND BY COMM. RIZZO TO APPROVE THE MINUTES WITH THE EXCEPTION OF MR. MEGEE'S STATEMENT. APPROVED.

A MOTION WAS MADE BY COMM. TORBERT AND SECOND BY COMM. RIZZO TO APPROVE THE BILLS. APPROVED.

COMM. ROYAL STATED THAT THE PARTS ARE ORDERED FOR THE REPLACEMENT OF THE STREET LIGHTS ON MARKET STREET. DPL ARE PROVIDING THE LIGHTS AT NO CHARGE. THE LIGHTING WILL NOT BE CHEAPER IN COST BUT MORE EFFICIENT.

COMM. RIZZO ASKED THE COMMISSION ABOUT THE DELINQUENT TAX PAYERS. PRES. SLATER STATED THAT ALL OF THEM WERE TAKEN CARE OF EXCEPT FOR TWO AND THE TOWN SOLICITOR IS TAKING CARE OF THEM.

COMM. ROYAL ASKED ABOUT THE MONEY THAT IS MADE FROM THE GLASS RECYCLING. COMM. RIZZO SAID THAT A VOTE WAS TAKEN YEARS AGO TO USE THIS MONEY FOR THE FLOWERS FOR THE TOWN. A MOTION WAS MADE BY COMM. TORBERT AND SECOND BY COMM. ROYAL TO PURCHASE STONE FOR THE SOUTH SIDE OF THE PARKING LOT. APPROVED.

PRESIDENT SLATER STATED THAT PERDUE, INC. IS BUILDING A NEW PLANT OUTSIDE OF TOWN AND WOULD LIKE TO HOOK IN TO OUR SEWER SYSTEM. NANTICOKE HOSPITAL ALSO WOULD LIKE TO HOOK IN TO THE SYSTEM EVENTUALLY, AND WOULD LIKE TO HAVE A LETTER TO TEMPORARILY DUMP SANITARY SEWER INTO OUR PLANT PRESENTLY FOR THE NEW MEDICAL CENTER LOCATED ON RT 13. NANTICOKE WILL BE RESPONSIBLE FOR RUNNING THE SEWER LINE ACROSS RT 13. A MOTION WAS MADE BY COMM. RIZZO AND SECOND BY COMM. TORBERT TO ACCEPT THE SEWER FROM NANTICOKE HOSPITAL. APPROVED.

A MEETING WAS HELD WITH SHORE BEST POULTRY, INC. AND THE COMMISSIONERS. PRESIDENT SLATER HAS THE MINUTES FROM THIS MEETING AVAILABLE FOR PUBLIC VIEW. A YEAR AGO AN AGREEMENT WAS MADE BETWEEN THE NEW OWNERS AND THE COMMISSIONERS. THE LAST MEETING WAS ABOUT THE LIMITS AND PRETREATMENT SYSTEM.

QUESTIONS WERE ASKED IN REFERENCE TO DELMARVA RURAL MINISTRIES BUILDING AN APARTMENT COMPLEX. PRESIDENT SLATER

STATED THAT THE COMMISSIONERS HAVE DONE EVERYTHING POSSIBLE,
ALTHOUGH THE TOWN OF BRIDGEVILLE DID HAVE TO TELL THEM THAT

WATER AND SEWER WERE AVAILABLE. MANY OF THE CITIZENS AT THE
MEETING SPOKE ON THE OPPOSITION OF THIS HOUSING COMPLEX.
LETTERS FROM THE COMMISSIONERS WILL BE MAILED OUT TO THE
REPRESENTATIVES IN OPPOSITION TO THIS COMPLEX.

COMMISSIONER CROCKETT STATED THAT THE POLICE DEPT. WOULD
LIKE TO HIRE TWO NEW PART TIME OFFICERS. THE FIRST BEING
EDWARD SABO WHO WORKS FULL TIME FOR DNREC. THE SECOND
OFFICER WILL BE HIRED IN THE FUTURE AFTER THE TOWN RUNS A
CHECK ON HIM. MOTION WAS MADE BY COMM. CROCKETT AND SECOND
BY COMM. RIZZO. APPROVED.

COMM. TORBERT REPORTED THAT LINES WERE REPLACED AND METERS
ON JACOBS DR. THIS WORK IS BEING DONE BEFORE DELDOT REPLACES
THE STREET.

DARYL TULL EXPLAINED THAT THE COMMITTEE FOR RIGHT TO VOTE
~~HAS PUT TOGETHER~~ A LETTER ASKING EACH AND EVERY RESIDENT OF
THE TOWN THEIR OPINION ON THE RIGHT TO VOTE. MR. TULL ALSO
ASKED FOR A POLE FROM THE COMMISSIONERS ON HOW THEY FEEL
ABOUT THE LETTER. PRESIDENT SLATER SAID THAT HE DID NOT
THINK THAT IT WAS FAIR TO TAKE A VOTE WITH OUT THE OTHER
SIDE BEING PRESENT. THE FOLLOWING COMMISSIONERS SAID THAT
THEY WILL ABIDE WITH THE DECISION OF THE RESIDENTS. COMM.
ROYAL, CROCKETT, RIZZO, TORBERT, AND PRESIDENT SLATER. A
MEETING WAS SCHEDULED FOR THE RIGHT TO VOTE COMMITTEE. THIS
MEETING WILL BE FOR EACH SIDE TO PRESENT THEIR PROPOSALS.
