

COMMISSIONERS OF BRIDGEVILLE  
REGULAR MEETING  
JUNE 12, 1995

Meeting was called to order at 7:00pm by Pres. Hardesty with a salute to the flag. All Commissioners were present. A motion was made by Comm. Slater to dispense with the reading of last months minutes and approve of the same. Motion seconded by Comm. Tull. Motion so carried 5-0. Motion was made by Comm. Slater to approve and pay bills presented in the amount of \$21,468.01 for the month of May. Motion was seconded by Comm. Fleming. Motion so carried 5-0.

Under correspondence, Pres. Hardesty had sent a letter of thanks on behalf of the Town for the donation of the computer valued at approximately \$400.00. The alderman court is currently using the computer.

The Flood Plan maps are here if anyone would like a copy.

The Commissioners received a letter from Broadcreek Realty about the vacant lot on N.Main next to 109 N.Main letting us know it was still for sale and the asking price was \$7500.00.

The town received a letter from FmHA concerning the Church street project and CDBG funding. We were granted another extension due to the bid hold up. The project must be completed by September 15, 1995. Hans Medlarz explained that the CDBG is very strict on the spending time frame of their money. They want the money spent within a certain amount of time. Church street will be starting on June 26.

The Town had received a letter from the State giving us the go ahead for construction on S.Main.

Under Old Business, the contract on the police station is still pending, we are waiting to sign the agreement after our attorney looks over the contract. Settlement will be complete by June 30, 1995.

A motion was then made by Comm. Slater to purchase a fax machine for the sewer plant to use for Miss. Utility service messages. The cost not to exceed \$400.00. Motion seconded by Comm. Tull. Motion so carried 5-0.

Under new business, Pres. Hardesty stated that application was made for liability coverage for directors and officers. He hopes to have some information in the next few weeks.

The Community Map Company had been contacted about doing another map for the Town for 1996. The only cost would be to the town would be the cost of postage for around 600 mailings. After much discussion Comm. Sipple stated that

she felt they should table the issue until next meeting so they had more time to look at the packet of information that was sent.

Pres. Hardesty brought up the fact that come August the Town would be losing an employee to maternity leave and that the office hours needed to be discussed. It was decided that they would discuss this issue at the next meeting to decide on office hours and closings.

Pres. Hardesty wanted to discuss the police uniform cleaning with the Comm. and wanted their opinion on what and how much to pay on the bill if any. Comm. Fleming felt that the uniforms needed cleaning we should at least consider a limited amount per month. Comm. Slater stated that since they are required to wear them, the town should contribute. Comm. Sipple asked if they had any type of washable uniforms? Comm. Fleming stated that these were better looking uniforms than washable. A motion was made by Comm. Slater to pay \$5.00 a month per officer for cleaning. Motion was seconded by Comm. Fleming. Motion carried 4-0 with Comm. Tull not voting.

Pres. Hardesty stated that he had received the rate study back from our engineers. They would like the Commissioners to look over the study and make a decision on the rates by the end of the year so that they can effective the first of next year and will help pay for the upgrades.

Pres. Hardesty then called for dept. reports.

Street Dept.- Comm. Sipple said that she had been approached by the school about the well building at the school in N. B'ville. If the town wasn't going to use it or tear it down, the school would like to have it for their use.

Farmers Supply Service has contacted her about getting some type of limited parking in front of their building across the street. Comm. Slater made a motion to place "TWO HOUR PARKING ONLY" signs from the driveway of Market Street Apts. to the alleyway behind Market Street Apts. Motion seconded by Comm. Sipple. Motion carried 5-0. The signs would be ordered.

Bids have been turned into Comm. Sipple for the repaving of streets that won't be affected by the project work. The Commissioner accepted a bid from Jerry's Paving and have turned the signed proposal over to Mr. Earle Timpson from the DOT for approval for state funding coming from Senator

Came back into regular session at 8:55pm with no motions made in executive session.

A motion was made by Comm. Slater to adjourn the regular meeting at 9:00pm. Motion seconded by Comm. Tull. Motion so carried 5-0.

Comm. Sipple said she also wanted to speak on the incident with Ms. MacLeod and her yard. A community service worker was here to do some work so she had him cut down the growth between the sidewalk and the roadway to help control a potential traffic problem. Comm. Sipple had not notified Ms. MacLeod that she was going to be doing this, now there is a warrant pending Ms. MacLeod's signature. Comm. Sipple stated that she wanted to go on record by saying she felt it was handled wrong.

Chief Orr responded that Ms. MacLeod does have rights and the police were called by her and they had to investigate, and that she (MacLeod) was the one who initiated the warrant.

Water Report- Comm. Slater stated that 3,560,000. gallons of water were supplied and 2 water leaks were repaired.

Sewer Dept- Comm. Slater stated that we had repaired 2 RBC motors and that the phragmitis was growing well. The new pump is in and a new adapter is being made and it should be up and running later this month.

Pres. Hardesty then called for Citizens Privilege.

William Smith owner of the pharmacy wanted to know if there were any plans of the project that he could look at. He wants to do some work and would like to coordinate it with the project. He was told that the plans were in the office and he could look at them any time he wanted>

Hans Medlarz , Engineer spoke on the new water wells and what progress has been made. He feels that Well #2 on the alley needs to be a single case well instead a double case well. We could erect one building there to create a total flow of 250 gallons per minute which could handle the whole town by itself. He spoke on what the towns option were as far as other wells and ways to do blending. Mike Collison from A.C. Schultes spoke saying that the step by step approach that DBF was taking was the best way to go from the towns point.

A motion was made by Comm. Slate to go with DBF's approach and drill a 5 x 8 single case production well behind the high school first, then a deep hole plus or minus 500 feet at the ball field to be screened at the lower cheswall sands if available. If not it would be screened at the same 5x8 production well. Motion seconded by Comm. Tull. Motion so carried 5-0.

A motion was made by Comm. Slater to go into executive session at 8:05pm. Motion seconded by Comm. Tull.
