

Commissioners of Bridgeville  
Regular Meeting  
July 10, 1995

Meeting was called to order by Pres. Hardesty with the salute to the flag. All commissioners were present.

Motion was made by Comm. Slater to dispense with the reading of last months minutes and approve of the same. Motion seconded by Comm. Tull. Motion carries 5-0.

Motion was made by Comm. Slater to approve and pay all bills presented in the amount of \$19,954.74 for the month of June. Motion seconded by Comm. Sipple. Motion carried 5-0.

Correspondence- Pres. Hardesty stated we had received a letter from Frank Calio concerning Economic Development in the county.

A letter was sent to Ms. MacLeod letting her know that her (10) ten days are expired. Motion was made by Comm. Slater to proceed with action form the town to have the yard cleaned and brought to standard. Motion seconded by Comm. Tull. Motion so carried 5-0.

The town had received a letter from Pet Poultry Products concerning their recent violations. They are requesting to be plugged from the town sewer.

Gary Walters, from E.R.M., was representing Shore Best, he was authorized to speak on their behalf. He feels that plugging is not the best solution, but due to the choice of hefty fines daily or plugging, they would choose to take the lesser of two evils. He felt that Shore Best should keep operating until a new permit is issued in Pet Poultry's name, since they (PPP) is operating under Shore Best's permit. He felt that with recent test results that had been done, Shore Best was operating much better and continuing to improve daily.

Comm. Slater stated that the town had also set up samplers, and were getting totally different results than what Shore Best was reporting. Mr. Walters felt that was due to different times that the sampler was set up, which caused different test results. Comm. Slater felt that some decisions have to made and action needs to be taken as soon as possible.

Phillip Mowbray, WWTP Manager, stated that Paul Janiga from DNREC felt that the town must take some type of enforcement action against Shore Best/Pet Poultry. Mr. Walters feels

that action should also be taken, but at the same time come up with some workable solution to all parties involved. Mr. Walters questioned why they could not be charged a penalty on a monthly basis until they were in compliance. Pres. Hardesty stated that they (Shore Best/Pet Poultry) was offered that in June and it was turned down. Mr. Walters, who is authorized to speak on Shore Best's behalf, would like to be offered that option again.

Comm. Slater made a motion to charge Shore Best a monthly penalty of \$1000.00 a month including June, which would be due at the town office by July 12, 1995 at 12 noon, and continue each month until they are in compliance, with no time limit to get into compliance. This charge is in addition to their monthly discharge fees. Motion was seconded by Comm. Sipple. Motion so carried 5-0.

Old Business- The old police station on Railroad Ave had been sold as of June 28 at the price of \$30,000.

A fax machine was purchased for the WWTP for Miss Utility locates.

Pres. Hardesty handed out the water/sewer rate study from our engineers, the board will meet at a later date to review.

Pres. Hardesty brought up the fact that an employee would be going out on maternity leave this month and a decision needs to be made about office hours. Comm. Sipple felt that the new part-time worker could just come in and answer phones and keep the office open for business. Pres. Hardesty said he would check with her and make sure that was alright with her .

The police uniform cleaning was brought up again, Pres. Hardesty felt that to alleviate any problems with bookkeeping the town should just pay all the bills. A motion was made by Comm. Slater to pay the monthly cleaning bills. Motion seconded by Comm. Fleming. Motion carried 3-2 with Comms. Sipple and Tull voting no.

New Business-Pres. Hardesty presented the commissioners with new employment applications and evaluation forms for their opinion. A some discussion, a motion was made by Comm. Sipple to accept the new forms. Motion seconded by Comm. Tull. Motion so carried 5-0

Pres. Hardesty contact our engineers, DBF, about doing a survey of the town to find out exactly what our corporate limits are. This can be done for the price of \$500.00. A motion was made by Comm. Slater to proceed with the survey, seconded by Comm. Fleming. Motion so carried 5-0.

Street Dept- Comm. Sipple stated that there have been new "one way" signs put up in the alley behind Layton's Hardware at both end of the alley to help control traffic and that there had been "2 Hour Parking" signs put up on N. Cannon across from Farmer's Supply. Both of the signs seem to be working. Mike Layton had some concern about the "one way" signs since some of his delivery trucks have unloading on one side only. The commissioners felt that this should not be a problem, just to let the truckers know that they are on a one way street to avoid any problems.

Sewer/Water Dept.- 3,450,000,000. gallons of water were supplied during the month of June. There has been 1525 feet of water main replaced on Church Street as part of the upgrade. Comm. Slater said that Teal Const. was working on Delaware Ave and they have one man hole done and are working on the other one. He stated that the well drilling should begin the week of the 24th. Comm. Slater also reported that the pump at Gateway Plaza had to be fixed again for the third time and we are looking a replacing it in the near future.

Citizens Privilege- Daryl Tull of S. Main, Bridgeville, spoke on the MacLeod situation, commending the commissioners for the effort that they are making and he hopes that they follow through with the letters that have been sent.

Gilbert Kandler of the Virginia 12th Volunteer Infantry Company was there to request permit to put on a civil war demonstration during the 1995 Apple-Scrapple Festival. They would be doing a demonstration that would require them to burn and use musket. There would be no spectators involved or handling the musket. A motion was made by Comm. Slater to grant them permission for October 6 & 7, 1995 to burn and use musket. Motion seconded by Comm.Fleming. Motion so carried 5-0.

Motion was made by Comm. Slater to enter into executive session at 8:15 with a short recess. Motion seconded by Comm. Sipple. Motion so carried.

Came back into regualr session at 8:45 with no motions made, only a discussion of personnel.

Comm. Slater made mention that we need to notify people who have roof leders tied into the storm drains to have them removed, since the sewer will not be able to handle this extra stormwater.

Motion made by Comm. Slater to adjourn at 8:47pm. Motion  
seconded by Comm. Tull. Motion so carried 5-0.
