

COMMISSIONERS OF BRIDGEVILLE
REGULAR MEETING
JULY 12, 1993

Meeting was opened by Pres. Tull at 7:00 P.M with a salute to the flag.

Comm. present: Daryl Tull, Stephen Cina, Robert Slater and Charles Royal. Comm. Torbert was absent due to another commitment.

Guest present: Linda Kapla, Ronald Fleetwood, Carol Gaisor, Bootsie Sipple, Walt Gilefski, Johnnie Wheatley, Phillip Mowbray, Doug Jones Chief Orr and Andy Robert.

A motion was made by Comm. Slater, seconded by Comm. Royal to dispense with the reading of last month's regular meeting minutes and to approve same. Motion was unanimously approved.

Motion was made by Comm. Slater, Seconded by Comm. Cina to pay bills as presented in the amount of \$33,223.22. Motion approved and carried.

Pres. Tull called for Department Reports.

ALDERMAN COURT - Alderman Court's report was given by Alderman Robert. Copy attached. He also reported that through the County the Court has a very capable assistant and the court records are totally caught up.

STREET DEPT. - Comm. Slater reported on the bid openings that were held today for alley and street repairs. Not all of them will be done. The exceptional bad ones will be, such as behind the Senior Center.

A special meeting will be held with the Comm. later this week to hopefully let the contract. There were 3 bids-93,677.50, 107,622.00, and 148,855.00. Delmarva Paving was the lowest bidder. Money will come from the State thru Senator Adams and Rep. Ewing.

WATER DEPT. - Mr. Cina reported several leaks had been repaired and 37 meters had been installed at the Apt. for Senior Citizens. There was a leak on Jacobs Dr. that needed barracades this week-end. The State says we need barrels with flashing lights at a work site. At the present we have to rent them. He suggests looking into buying 6-10 barrels w/lights at approx. \$90.00 a barrel. Municipal St. Aid will be contacted to see if money can be used for the barrels from those funds.

WASTE WATER TREATMENT PLANT - Mr. Royal said the plant is holding its own. He informed everyone that Phil Mowbray had passed his Level 3 Certification Test and that he personally wanted to congratulate Phil. He is more of an asset to the Town than ever. The largest expense are the chemicals Mr. Royal had found out. Hopefully the referendum will be passed and help the cause.

Pres. Tull's Report - Ralph & Paul Adams has renewed their request for a new and deeper well. The referendum is still on track, Bond Council has the final say and he had hoped to hear from our attorney today that they had approved our request so we can proceed with the referendum for the new water/sewer lines. It is something the Town needs and half of the needed money will come in a form of a grant from FmHA. We do need these improvements and hope that the residents will see the need and agree to it because it will cost them less with the grant than it will later with no help.

Pres. Tull said in reply to several inquiries if the School Board had applied for a variance-yes, they have. We are waiting to hear from the Board of Adjustment to set up a date for the public hearing.

CITIZEN'S PRIVELEGE-Linda Kapla Chairman of the Second Apple-Scapple Festival and three of the executive committee came to try to clear up some problems concerning several areas including other committee persons not showing up for the meetings, etc. Linda and those of the committee that were here said they needed to clear up some things such as expenditures, street closing, etc. They wanted to ask for a meeting with the Commissioners. Pres. Tull informed them that the Commissioners could not meet with them in a body at a private session. It would have to be an advertised meeting. This is due to State laws. He would be glad to call a special meeting with them but it would have to be a public meeting. He asked who the other executive committee members were who had not attended the meetings held on every 1st and 3rd Tues. of the month and he would be in contact with them and see that they were reminded. They are Comm. Slater, Bonnie Workman, Marlene Saunders and Olivia Blackwell. A copy of last year's expenditures were given to each Commissioner. A \$1,000 donation has been given by Mr. Stevenson of the Sussex County Council. Seaford Chamber of Commerce has indicated a grant for the festival. The Committee here questioned about the \$500 donation by the Town for the electric. They seem to think it was not received. Mrs. Pusey to look into it.

Mr. Royal asked if name would remain the same for the festival. The concensus was that it would.

Being there were no other Citizens imput, Pres. Tull asked for a motion to go into executive session concerning personnel and legal matters.

Motion was made by Comm. Slater, seconded by Comm. Royal to go into executive session at 7:55 P.M.

Meeting adjourned at 8 P.M.

The regular meeting was called back into session at approximately 8:30 P.M.

Commissioner Royal brought up the subject of work clothing for the men at the plant. After a discussion Commissioner Slater made a motion that the Town will not purchase work clothes for it's employees. Motion seconded by Commissioner Royal. Motion carried.

Commissioner Slater motioned that the meeting be adjourned, seconded by Commissioner Cina. Motion carried.

Meeting adjourned at 9 P.M.
