MINUTES

COMMISSIONERS OF BRIDGEVILLE AUGUST 11, 1997 - 7:00 P.M. TOWN HALL

I. CALL TO ORDER

The regular monthly meeting of the Commissioners of Bridgeville was called to order at 7:00 P.M. by President Robert Bennett. Present: President Bennett, Commissioner Charles Singman, Commissioner Jack Dalton, Commissioner Robert Slater and Commissioner Margaret Sipple. The meeting began with a salute to the flag.

II. APPROVAL OF MINUTES

The reading of the minutes from the July 14, 1997 regular meeting was dispensed by a motion from Commissioner Sipple, seconded by Commissioner Singman; motion carried unanimously.

III. APPROVAL OF MONTHLY BILLS

See breakdown per fund attached. Monthly bills showed estimated salaries. Commissioner Slater made a motion to pay stated bills as presented. Motion was seconded by Commissioner Singman; carried unanimously. Commissioner Singman asked what percent of property taxes had been received. President Bennett did not have those figures.

IV. PRESIDENT'S REPORTS

A. CORRESPONDENCE

1. A letter was received from the Delaware League of Local Government asking if the Town is interested in rejoining. Due are \$550.00 a year. It was tabled by President Bennett.

2. President Bennett said a meeting is scheduled at the Seaford Fire Hall on August 12, 1997 at 7:00 P.M. on Water Fluoridation if any Commissioner would be interested in attending. Commissioner Dalton stated he would be able to attend.

B. DEPARTMENT REPORTS

1. POLICE DEPARTMENT - Monthly report attached.

Presented by Commissioner Singman. He reported a significant decrease in traffic arrests for the month. He said at this point if statistics continue the way they have for the last couple of months, the Town is going to be in serious financial trouble in another couple of months. The revenues estimated by the police department at the beginning of the budget period are going to fall way short. Commissioner Singman said July is one of the busiest months, and traffic arrests are down by 200. He said one candidate applied for an officers job, but decided to stay with the force he was with. He said the chief had told him that no one else had applied, and he was concerned because the next police academy does not convene until 1998.

2. WASTE WATER - Monthly report attached. Presented

by Commissioner Slater. He reported there were no N.P.D.E.S. violations. There were three waste haulers using our facility for a revenue of \$3,935.75. Commissioner Slater said he would like to see the sludge disposal disposed of within the next 60 days at an approximate cost of \$3,000.00. A progress meeting on the W.W.T.P. upgrade was held August 1, 1997. Commissioner Slater was unable to attend. Mr. Doug Jones reported they are trying to get the electricity down on the pipes and trying to finish up the chemical building. The next meeting is scheduled for September 5, 1997 at 9:00 A.M.

3. DRINKING WATER - Monthly report attached.

Presented by Commissioner Dalton. The average gallons of water pumped per day was 152,000.

Commissioner Dalton said, unrelated to the water department, he wanted to thank the Town employees for the fine job they did trimming the trees by the Town Hall and the water plant.

Commissioner Dalton said he is continually working with customers in Town who have questions concerning their meters. He said Mr. Jones worked with a plumber on one customer's home trying to get to the bottom of the high water consumption. There are a couple of customers that the office is having difficulty in collecting their payments. If arrangements cannot be made, those customers will be tagged for shut-off.

Commissioner Dalton said at the last meeting he was directed to address the request from Cannon Cold Storage for either a reduction in their water rates or permission for them to drill a new well. He said Mr. Jones gathered rates from surrounding towns (see attached). He said, at this point from what can be determined, they do not see evidence to move in either direction. Commissioner Dalton and Mr. Jones will be meeting with representatives from Cannon Cold

Storage and explain the Town's position to them. If any changes come up, he will report it to the Commission.

4. STREETS - Presented by Commissioner Sipple. Several potholes have been repaired. She reported the indentation on Elm Street had been repaired. Commissioner Sipple said the manhole cover on South Main Street has been welded shut.

Commissioner Sipple reported that the new flagpole at the Town Hall was donated by a resident.

5. ALDERMAN'S REPORT- None available. Commissioner Dalton asked if any advertising for a new Alderman had been done as discussed several months ago. President Bennett said nothing had been done to date.

V. OLD BUSINESS

1. President Bennett presented a copy of the 1997 Sussex County Profile Magazine which Bridgeville did place an advertisement. After much discussion, Commissioner Slater made a motion to place the 1/2 page advertisement in the magazine for 1998 for a cost of \$275.00. Motion was seconded by Commissioner Sipple; carried unanimously.

2. Commissioner Slater said he had just received the information on the water and sewer minimum charges from Mr. Mike Megee. Each Commissioner had received a copy of Mr. Megee's report. Commissioner Slater suggested all Commissioners study it, and he will talk with Mr. Megee. Commissioner Slater made a motion to table the matter until the September meeting. Motion was seconded by Commissioner Singman.

3. Commissioner Singman said he had not received any report from Chief Handley Orr on the abandoned cars in Town.

4. Commissioner Sipple had no report on the Street Adoption Program.

VI. NEW BUSINESS

1. At 7:15 P.M. President Bennett turned the meeting over to Mr. Rick Tull of Lank, Johnson & Tull, auditors for the Town. Mr. Tull explained the single audit which is mandated by federal regulations. The single audit was completed for the Town due to the fact the Town received federal funding in excess of \$100,000.00. He reported there were no non-compliances found. Mr. Tull said the Town has assets in excess of \$13 million and liabilities of approximately \$2.5 million. He said the current year's revenue was about \$2.8 million. Expenditures were \$4.7 million, leaving a deficit of a \$1.9 million. Of that, \$2 million was funded by federal dollars. The Town was in

the black \$217,000.00. Mr. Tull said much of the funding comes from state and federal funding to support new roads and infrastructure.

President Bennett said the payroll processing that was recommended will probably start in September or October.

President Bennett said the Town does not have an up-to-date property equipment list.

Commissioner Singman questioned the \$217,000.00 in the black for the year and that most of that money is set aside for projects in the working or not yet completed. Mr. Tull said that money is not cash flow money. Commissioner Singman wanted to clarify that this audit is accepted by general accounting principles.

2. President Bennett presented the second reading of Ordinance 97-2. An ordinance to amend Chapter 128, Section 1 of the Code of the Town of Bridgeville relating to schedule of charges and fees of the community sewer of the Town of Bridgeville (see attached). Commissioner Slater made a motion to adopt Ordinance 97-2. Motion was seconded by Commissioner Dalton, carried unanimously.

Commissioner Slater said the only property owner on this particular sewer line from Gateway Plaza has paid \$18,200.00 so far in impact fees. The property owner is pumping like an industry would. He said if his peak is 200,000 gallons pumped to the Town, he has way overpaid according to the new rules. Commissioner Slater said to save any more problems, he would like to make a motion that with the number of seats at the restaurant at this point, the owner should be considered to be paid in full to the Town. If more seats are added after this point, then the owner will have to pay the \$900.00 per EDU. After much discussion, motion was seconded by Commissioner Dalton; carried unanimously.

President Bennett said he received a call from the daughter of Mr. Scott stating she wanted to settle the Gateway Plaza matter. Commissioner Dalton said if his memory was correct, there was \$200,000.00 that was to be paid from the Town of Bridgeville to the family through the year 2000 or 2003, if that amount was collected on that line. Commissioner Slater said two or three agreements had been signed, but no final agreement was ever signed. Commissioner Slater suggested the Scott family send the Town a final draft of what they are proposing. He said the Town was to pay half of all profits to the Scott's. The Town has not paid because the Town has spent quite a lot of money on the upkeep of that pumping station. Any profit made, the Town is suppose to get half. The rates are set by the Commissioners. Commissioner Slater said he thought \$1,500.00 a gallon was not right, but does think \$3.00 a gallon is good. The property owner still will pay for what he is pumping.

3. President Bennett reported \$96,375.00 for the Laws Street paving project has been granted from Rep. Ben Ewing. He said there are two ways to complete the project: (1) having DEL DOT do the work, which will not be done until the spring or summer of 1998, or (2) the Town can put out bids on the project. He said Davis, Bowen & Friedel want \$12,550.00 to administer the bid. After much discussion, Commissioner Slater made a motion to let Davis, Bowen & Friedel handle the Laws Street project as long as they are within the allotted funds. Motion was seconded by Commissioner Singman; carried unanimously.

Commissioner Slater did ask Mr. Jones if there was a storm water drain in that location that would be involved in this project. President Bennett said the specs stated the storm water drain would be taken care.

4. Commissioner Singman said Chief Orr submitted three bids for the repair of the blown engine on #4 police vehicle. The bids are from Carey's Inc. in Laurel of \$3421.30, Frederick Motors of Seaford of \$4121.00, and Sharks Service Center of Bridgeville, \$3500.00. Commissioner Singman said \$5,000.00 had been put aside in the police department budget for vehicle maintenance and repair. He made a motion to accept the bid from Careys, Inc. to repair police car #4 for \$3421.30. Motion was seconded by Commissioner Slater; carried unanimously.

President Bennett reported a letter from the state was received stating the Town would be receiving \$10,370.00. That money can be used to repair the car, street maintenance or debt reduction. All that is needed is a letter stating what the money is going to be used for.

Commissioner Singman said on July 2, 1997, Chief Orr sent to the Criminal Justice Council an application for a block grant law enforcement program in the amount of \$6325.00. This grant can be used for hiring, training, overtime payment and purchasing of equipment. The brakes have been repaired on police car #6.

VII. CITIZENS PRIVILEGE

1. Mrs. Cindy Truitt said on May 12, 1997 she was told by Commissioner Sipple that she would try to get the street sweeper in motion to clean the streets. She said taxes were raised to help cover the services needed in Town. Mrs. Truitt feels it is the responsibility of the water and sewer department to cover the over all street maintenance and not that of the citizens of the community. She said some employees in that department are doing all they can, and maybe someone could be hired to lighten their load. She showed the Commissioners pictures she had taken of clogged drains throughout Town. Mrs. Truitt said the worst ones are on Williams and Laws Streets, and Delaware Avenue.

Commissioner Sipple said a sweeper broom was purchased last year, but the Town does not have the manpower to

operate it at this time. The employees at the plant are working daily with the construction people on the sewer project which is a priority. Mr. Jones explained the engineers wanted \$32.00 to have an inspector on site, so to save the Town money, he has been the inspector on the project which takes a great deal of his time. Commissioner Slater said after the sewer project is completed, hopefully the employees will have time to work on the street projects.

President Bennett asked Mr. Jones to get him prices for hiring a youth or two to help out. He questioned what happened to the kids who use to work under the CETA program. Commissioner Sipple said the Town does have a couple of community service kids working, but a Town employee still needs to go out on the job with them.

Mrs. Truitt said she thought the Town was back in the black. Commissioner Slater explained it is labor-if we go out and hire people, then the Town will not be in the black. He said the employees will try to get to the street cleaning just as soon as the sewer project is complete.

2. Mrs. Neva McClary asked when the five large holes in the alley behind the grocery store were going to be repaired. Commissioner Sipple said she had discussed the problem with Mr. Rick Passwaters and Mr. Jones. It seems the holes have been patched before and it just doesn't hold. The alley really needs to be resurfaced. Mrs. McClary also had a complaint about the tall grass at the Sudler House on North Main Street.

3. Mr. Orlando Iannuzzi of 210 Market Street Apts received a capitation tax of \$15.00. He asked for relief from paying the tax due to the small amount of income he receives each month. The Commissioners advised him to discuss a payment arrangement with the Town Clerks, because the Commissioners could not waive the tax bill.

4. Mr. Donald Kirby asked how many full-time police officers the Town employs. President Bennett told him there is one chief and one full-time officer.

Mr. Kirby asked if Town Clerk, Alma Fleetwood, had mentioned to the Commission that Mrs. Wanda Abbott's building permit had run out. Mr. Kirby said a building permit has never been posted, and the original permit ran out in April of this year. Mr. Kirby also reported that the back yard is full of debris. Commissioner Singman told Mr. Kirby to contact him on Tuesday for a further discussion on the issue, and he then would contact Chief Orr.

5. Mr. Charles Royal wanted to know the specific status of the police in Town. He wanted to know if service had been deleted completely. Commissioner Singman responded by saying the police department has not been deleted in Town. He said numerous applicants have applied for the vacant officer's job, but have been rejected by the police

department. Commissioner Singman said he spoke to one of the applicants who applied over three months ago to see why he chose not to come to Bridgeville. Commissioner Singman said because of the shortage he directed the chief of police over a month ago to patrol a minimum of four hours a day, in uniform, the streets of Bridgeville. Chief Orr told Commissioner Singman only one applicant had been received since he put an ad in the media. Commissioner Singman said he feels our part-time officers are not being used to the fullest extent, and that is something he is trying to work out. He said two or three officers out of the seven part-time officers do work an average of fourteen plus hours a week. He does not feel it is fair that the other part-time officers choose not to work at night or holidays. Commissioner Singman said he has made it clear, that if they want to be part time police officers, they need to accept the same responsibilities as all the other officers. This situation has not been resolved. Commissioner Singman said he has been giving the chief different ideas as to how to recruit officers to our Town. He said he had informed the chief about the five officers who were laid off in the Dover area two months ago. He has not heard whether they were approached or not. Commissioner Singman said the police department in this Town is operating, but on limited staff. He said he told the chief on numerous occasions that the money is available to hire a new officer. He said every time the budget is discussed, he made the motion to pay salaries first. If a question of a policeman coming to this Town is one of salary, the Town would guarantee he would be paid, as all other employees are.

Mr. Royal said you can select the priorities all you please, but when you are not affording the security of the citizens of this Town, the list should be changed. President Bennett said to call 911-if a Town officer is not available, a state police officer will be dispatched. Commissioner Singman said he was aware of several incidents where officers had not responded to calls. Commissioner Singman said he had received complaints from citizens, in which he has no police powers or authority to arrest. He went to a call on Edgewood Street as well as one on Church Street just to see what was going on because no police had responded. Commissioner Singman said he is fully aware of Mr. Royal's concerns.

Mr. Royal questioned the relationship between the Town and the state regarding Church Street. Commissioner Sipple said Church Street is scheduled to be paved. DEL DOT said the contracts would be going out in July. The bypass is also on schedule for 1998. Commissioner Sipple explained that once the new bypass is completed, the Town has the authority to force trucks to use it and not travel through Town except for the local deliveries.

VII. EXECUTIVE SESSION

Commissioner Slater made a motion to go into Executive Session at 8:00 P.M. Motion was seconded by Commissioner Singman; carried unanimously.

The Commissioners reconvened to regular session at 8:12 P.M. No motions were made.

VIII. ADJOURNMENT

The meeting was adjourned by President Bennett at 8:15 P.M.



ORDINANCE NO. 97-2

AN ORDINANCE TO AMEND CHAPTER 128, SECTION 1 OF THE CODE OF THE TOWN OF BRIDGEVILLE RELATING TO SCHEDULE OF CHARGES AND FEES OF THE COMMUNITY SEWER OF THE TOWN OF BRIDGEVILLE

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COMMISSIONERS OF BRIDGEVILLE AS FOLLOWS:

Section 1: That Section 128-1, Chapter 128, relating to the schedule of charges of fees of the community sewer of the Town of Bridgeville be amended by deleting the following:

"F. For all sewer connections on the sewer line from the Bridgeville Mall Limited Partnership, there shall be a sewer tapping fee of [ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00)] per equivalent dwelling unit."

and substituting in lieu thereof the following:

"F. For all sewer connections on the sewer line from the Bridgeville Mall Limited Partnership property, there shall be a sewer tapping fee of NINE HUNDRED DOLLARS (\$900.00) per equivalent dwelling unit.

Section 2: This Ordinance shall become effective upon its adoption by a majority of the Commissioners of the Town of Bridgeville.
