

MINUTES

COMMISSIONERS OF BRIDGEVILLE

SEPTEMBER 9, 1996

TOWN HALL

I. CALL TO ORDER

The regular monthly meeting of the Commissioners of Bridgeville was called to order at 7:00 p.m. by President Howard Hardesty. Present; Mr. Hardesty, Mr. Bob Slater, Mr. Jack Dalton, Mrs. Margaret Sipple, and Mr. Gene Crockett. Meeting began with a salute to the flag.

II. APPROVAL OF THE MINUTES

The reading of the minutes of the meeting of August 12, 1996 was dispensed by a motion from Commissioner Sipple. The motion was seconded by Commissioner Dalton. Motion carried unanimously.

III. APPROVAL OF BILLS

See breakdown per fund attached. Monthly bills do not include salaries. Motion to approve bills was made by Commissioner Slater; seconded by Commissioner Crockett; motion unanimously carried.

IV. PRESIDENTS REPORT

A CORRESPONDENCE

1. A letter was received from the County Engineer concerning the project on Church Street. Some lines were damaged and this resulted in an extension of the warranty time limit for an additional year.

2. A letter was received from the Delaware Commission of Veteran's Affairs who is hosting a Veteran's Day Celebration November 11, 1996.

3. Tuesday, September 17, 1996, the Delaware Emergency Management Agency is holding a State Building code symposium at the Dover Sheraton.

4. A letter was received from the National Victim's Center. This was given to Commissioner Crockett for review and further action.

5. A ground breaking ceremony for the new Western Sussex Boys and Girls Club will be Monday, September 16, 1996.

6. Nanticoke Rotary Club will hold its Community Service Awards Dinner at Blades Fire Hall.

7. A letter was received from the Insurance Department asking if the Town would again be interested in a safety audit. A 20% refund would be given. This cost of the audit would be more than the savings, so the Commissioners were not interested.

#### B. DEPARTMENT REPORTS

1. POLICE - Monthly report attached. Presented by Commissioner Crockett.

2. WASTE WATER - Monthly report attached. Presented by Commissioner Slater. There has been no progress on land application of sludge. McDonald's lift station; a price was obtained on a pump, but this has been tabled because of other projects. Digester cleaning has been completed at a cost of \$27,141. New Projects: Woodbridge High students will be touring the plant on the week of October 8th through the 11th as part of their Science class. Western Sussex Water and Sewer Advisory meeting for October will be held in Bridgeville at the Town Hall.

3. DRINKING WATER - Monthly report is attached. Presented by Commissioner Dalton. The Town residents are getting used to the monthly billing. Commissioner Dalton questioned whether or not there was a minimum charge for water. President Hardesty stated that the only minimum charge was the meter charge of \$7.00 and that this may be a matter for future consideration. A letter was received from Hopkins Construction stating that on two water lines, there were plugs left in, which caused two customers problems with their water lines. This has been fixed. There was a SCAT meeting and Alderman's Courts were discussed. SCAT has taken a position that standards should be set for qualifications and operating procedures. Dennis Schrader reported that numerous items of concern were reviewed at a meeting held by the League of Local Governments, SCAT, The Association of Coastal Towns, and the Alderman's Association. There was also a discussion at the SCAT meeting about the State budget process. It was suggested that the Town's budget needs be defined and submitted earlier. There is a move is to increase the size of the Municipal Street Aid fund. Del DOT Transportation Council for Sussex County met to discuss future needs and problems. Each town was asked to submit requests and problem areas by September 20, 1996. A concern was that the County's Comprehensive Plan was based on Del DOT's plans for future expansion. All of the future development seems to be centered around Route 13. The State held a meeting on the 800 Megahertz Radio Service that the State is instituting

for communications purposes. The total price for the updating will be \$100,000 with the State matching 50% funding with grants but the Town would have to pay the remainder.

4. STREETS Presented by Commissioner Sipple. Some of the streets have been swept. Sewer catch basins on First and Cannon has been cleaned out and a new trash can was put on the corner. There are to be two bus stops in Bridgeville. One on North Cannon Street and one by Laverty Lane. There has been a sign put up marking Route 404. Route 13 A North and South are to be repaved. No time frame for the repaving of Market Street has been set.

5. ALDERMAN'S REPORT - Monthly report attached.

#### V. OLD BUSINESS:

1. STREET LIGHT PROPOSAL - Chief Orr and President Hardesty looked at Cannon and Church Street; First and Cannon Street; First Street and Gum Alley; Church and Spruce Street; Vine Street; Spruce Street and by the new plant entrance on Route 404 for the upgrading and installation of street lights. Delmarva Power will be installing the new lights around October 1st. The current monthly charge for street lights is \$1,412.97. The new monthly cost for 162 lights would be \$1,670.37. - an increase of \$257.40 per month.

2. SEWER AND WATER ADJUSTMENTS - Commissioner Slater reported that several adjustments for water leaks have been made on water and sewer bills. There is an adjustment on a \$1,600.00 bill for the Union United Methodist Church needed. Commissioner Slater moved to adjust the sewer portion of the bill for the Church. The motion was seconded by Commissioner Crockett and carried unanimously.

3. PROPOSED CURFEW -(See attached copy). Dennis Schrader reviewed an ordinance from the City of Harrington for a format. Mr. Schrader read a proposed draft of an ordinance setting a curfew time of 11:00 p.m. on week nights and 12:00 on weekends for youths under the age of 17. There will be certain exceptions for emergencies and married youths. He asked for review and comments from the Commissioners so that the proposed ordinance could be read at the next regularly scheduled meeting. Copies will be made up and distributed for review. Commissioner Crockett and Mr. Schrader will meet with Chief Orr to go over the ordinance. Any citizen may offer input.

#### VI. CITIZEN'S PRIVILEGE

A. Daryl Tull asked about the possible benefit of the proposed annexation. He asked if letters were sent out by

the Town soliciting letters from residents asking for their land to be annexed. He further asked if the letters or Commissioners made any guarantees of any incentives, tax breaks, impact fees or future tax breaks to the landowners of the areas to be annexed. Commissioner Crockett expressed his opinion that by growth of the town, the population and tax base would expand easing future tax burdens.

Commissioner Dalton stated that he had spoken to Ruth and Thurman Adams concerning the possible annexation of their property. He said that he did so because he was told by developers in the area that Bridgeville was being looked at for development, but has had a history of being hostile to businesses. If the Town were to annex these properties and make them attractive to businesses, the Town could bring businesses into the Town. Mr. Dalton stated that the Town had passed a resolution that said that the Town would tax those properties at the same rate of the County taxes. The properties would not be taxed as long as the properties were not sold or developed. Mr. Tull asked whether the Town could afford to provide services to the annexed areas. He was told by the Commissioners that the areas were already served. Mr. Tull asked if the area proposed was principally being annexed to raise revenue from traffic tickets for violators on Route 13. He was told that was not the case.

Mrs. Mary Cina asked if the Town could solicit land to be annexed. Mr. Schrader told her that the charter requires the Commissioners to accept petitions for annexation. Once the charters are received, surveys are performed to get the Town to the point to be able to pass a resolution for annexation. Mr. Schrader also reminded everyone that there is a countywide zoning moratorium in effect. Mary Cina expressed a desire to have the Police patrol Elm Street if annexed and that one of her neighbors was not even aware that she would have to pay Town taxes if annexed. Mr. Phillip Davis expressed his opinion that if Bridgeville were not allowed to expand, that Seaford would take over the Town. He also wanted to express his appreciation for the Town's help and support for the recent outdoor gospel event. The Town had agreed to close off the street and provide lighted barriers for the event. Commissioner Crockett commented that the Police have been charged with the duty of enforcing speed limits and have been doing a thoroughly professional job. He also went on to say that other than contact for speeding violations, the police can check other things like insurance compliance, sobriety, illegal substances, outstanding warrants, etc. Commissioner Crockett gave the Police Department his personal recommendation for an outstanding job.

## VII. NEW BUSINESS

1. Hans Medlarz, Engineer for Davis, Bowen and Friedel, updated the Commissioners on the progress of the water and sewer plant upgrade. (See attached) The low

bidder was the Hopkins Construction Company. Mr. Medlarz had checked their bond and bid documents. The low bid was \$134,656 for improvements to well numbers 5 and 2. President Hardesty had advised Mr. Medlarz that the Town did not want a painted block building. The add on option #3 under Hopkins Construction for \$10,000 is for a brick building or \$5,400.00 for a split face block building. The funds are available. The total shortfall of \$330,000 will have to be addressed on the sewer end of the project. Mr. Medlarz's recommendation was to award the full project amount to Hopkins Construction contingent upon Rural Economic Development's concurrence. The lowest sewer bid came in at \$794,000 from Hopkins Construction. The available funding from the original application is \$500,000. Mr. Medlarz has forfeited his \$27,000 portion of the final billing to help bring the project in within the budget. Commissioner Dalton again went on the record with a complaint on the quality of the paving job on Main Street. Mr. Medlarz assured Mr. Dalton that the base on the street was adequate to hold up the paving job for the long term. Mr. Medlarz reported that the State owed the Town \$441,000 for the street project. He told President Hardesty to call the State and tell them that the project is finished so the Town could be paid. Mr. Medlarz also reminded the Commissioners that when all the funding is added the Town will be \$330,000 short. He asked Denise MacLeish about the possibility of obtaining more money from Rural Economic Development. He was told that there would be no money available this fiscal year, and if any were available next year it would be loan money coming out of guaranteed programs. Mr. Medlarz told Ms. MacLeish that the Town would not be seeking any more loan money. It was Mr. Medlarz's recommendation to award the contract for the water and sewer plant upgrade to Hopkins Construction for the base amount minus item number 7, which is the RVC installation. There should also be a change order to recover the difference in the split face on the building. The Town is now servicing the entire northwest quadrant of Sussex County. Greenwood is now planning an expansion of eighty homes in their area. Commissioner Dalton moved to accept the bid of \$134,656.00 for the well site building from Hopkins Construction with option number 3 of split face block at the cost of \$5,400.00 with the color of the block and roof to be determined at a later date contingent upon approval of Rural Economic Development. Commissioner Slater seconded the motion and it was unanimously passed. Commissioner Slater made a motion to accept the bid on the waste treatment improvement project by Hopkins Construction for \$794,455.00 minus the \$350,000.00 item number 7 retaining item numbers 6 (\$17,000.00) and 14 (\$67,000.00) contingent upon approval from Rural Economic Development. The motion was seconded by Commissioner Dalton and passed unanimously. Commissioner Slater asked Mr. Medlarz to explain the procedures for acceptance of the bids and approval from Rural Economic

Development. It is expected to take about two months. Commissioner Slater expressed his desire that the project not be started in the month of January due to possible inclement weather.

#### VIII. ADJOURNMENT

Commissioner Slater made a motion to adjourn the meeting at 9:20 p.m. The motion was seconded by Commissioner Dalton and passed unanimously. The Commissioners reconvened at 9:25 p.m. for a brief motion. All the Commissioners were present. Commissioner Dalton made a motion to contact the Delaware Department of Transportation about the possibility of changing the parking of the cars to the North side of Market street west of Williams Street. The motion was seconded by Commissioner Slater. It was passed unanimously. Meeting was adjourned at 9:27 p.m. by a motion from Commissioner Dalton. Motion seconded by Commissioner Slater and passed unanimously.



**COMMISSIONER'S MEETING**

**September 9, 1996**

Gallons pumped for the month 3,727,000. An average of 120,000 gallons per day

We have made very few adjustments in billing this month, some people are still discovering that they have leaks, and one forgot to get the metered hose from town hall to fill a pool.

We did repairs on two meter pits where residents complained of low water pressure, and found drilling coupons left in the lines by the contractor. Neither of these two involved cutting into the street, so our repair cost was low. It is understood that any major cost incurred, should this happen again, will be passed on to Hopkins.

**SCAT**

**Alderman Court**

A team from SCAT met with the Governor's office to discuss courts. Gov. was not aware of importance of courts to some towns. Dennis Schrader mentioned three areas of concern, 1. They are not a court of record. 2. The judges lack training. 3. There are no standards for training.

It was suggested that 1. They be made a court of record. 2. Standards should be developed for proper training and qualifications to hold office established. 3. Judges be properly trained.

**State Budget Process**

Municipalities need to be involved in the budget process. As it stands now, our needs are brought up after the budget is passed and have to be fit in later. It is suggested that we make our needs known early in the process.

A move is on to increase the size of the Municipal Street Aid Fund.

**Transportation**

SCAT met with DelDot's Transportation Council for Sussex County to discuss future needs and

problems. Each town is asked to submit any requests or problems to said council by 9-20-96 so that they may be included in future plans.

It was mentioned that Sussex County's Comprehensive Land use Plan is based on DelDot's transportation plans. If the current Comp. plan is enacted, all development will be focused on areas bordering present municipalities. If this is to occur, there needs to be a determination of how infrastructure will be funded to lessen the burden on the towns.

#### "800" Meg Radio Service

The State has allocated 40 million dollars to convert to the new frequency. The are planning to fund 4500 state users and expect 2500 additional users from the towns, fire companies and EMS units. Current matching fund plans call for the towns to receive 50% grants for needed equipment. It was stated that this amount is too little, due to the fact that some towns such as Bridgeville are facing upwards of \$100,000.00 and could not afford the remaining 50%. We need to lobby our representatives to change this situation. New Castle county was funded by the State due to the fact that they were the Beta system.

Current prices for equipment range from \$2500.00 to over \$4000.00 but are expected to be lower by the time the system is operational in Sussex County ( approximately 3 years.)

AN ORDINANCE TO ESTABLISH A NOCTURNAL CURFEW APPLICABLE TO JUVENILES; PROVIDING RESPONSIBILITY FOR PARENTS OR GUARDIANS OF JUVENILES AND OPERATORS OF ESTABLISHMENTS; AND THE PENALTIES FOR THE VIOLATIONS THEREOF.

WHEREAS, the Commissioners of Bridgeville have determined that there has been an increase in the range of unacceptable behavior of juveniles including vandalism, public drinking and littering, drug use, breaking and entering, and harassment of the residents, as well as violence; and

WHEREAS, persons under the age of 17 are particular susceptible and by there lack of maturity and experience to participate in unlawful activities or to be the victims of older perpetrators of crime; and

WHEREAS, curfew for those persons or juveniles under the age of 17 will be in the interest of the public health, safety and general welfare and will promote the public's good, safety and welfare; and

WHEREAS, parental responsibility for the whereabouts of children is the accepted norm and legal sanctions to enforce such responsibility have demonstrated the effectiveness of many communities, that the Commissioners of Bridgeville have determined that a curfew ordinance will increase parental responsibility for juveniles within their control and decrease juvenile delinquency; and

WHEREAS, the passage of this ordinance is pursuant to the police powers of the Commissioners of Bridgeville;

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE COMMISSIONERS OF BRIDGEVILLE AS FOLLOWS:

Section 1: It shall be unlawful for any person under the age of 17 years to congregate, loiter, wander, stroll, stand or play in or upon the public streets, highways, roads, alleys, parks, public buildings, places of amusement and entertainment, places of employment, vacant lots, or any public places in the Town of Bridgeville, either on foot or in or upon any conveyance being driven or parked thereon, between the hours of 11:00 p.m., local time, until 6:00 a.m. on all nights of the week except Friday and Saturday nights which shall be from 12:00 midnight, local time, until 6:00 a.m., unless accompanied by his or her parent, guardian, or other adult person having his or her care, custody or control.

Section 2: It shall be unlawful for the parent, guardian or other adult person having the care and custody of a person under the age of 17 years to suffer or permit by insufficient control to allow such person to congregate, loiter, wander, stroll, stand

or play in or upon the public streets, highways, roads, alleys, parks, public buildings, places of amusement and entertainment, places of employment, vacant lots, or any public places in the Town of Bridgeville, either on foot or in or upon any conveyance being driven or parked thereon between the hours of 11:00 p.m., local time, until 6:00 a.m. on all nights of the week except Friday and Saturday nights which shall be from 12:00 midnight, local time, until 6:00 a.m., unless accompanied by his or her parent, guardian, or other adult person having his or her care, custody or control.

Section 3: It shall be unlawful for any person, firm or corporation operating places of amusement or entertainment, or any agent, servant or employee of any person, firm or corporation to permit any person under the age of 17 years to enter or remain in such places of amusement or entertainment during the hours prohibited under this section, unless such person is accompanied by his or her parent, guardian or other adult person having his or her care, custody or control.

Section 4: The following shall constitute valid exceptions to the operation of this Ordinance;

(a) When a person under the age of 17 is assisting in an actual emergency;

(b) When a juvenile is returning home by a direct route (without any unnecessary detour or stop) from and within one hour of the termination of any school activity or an activity of religious or other voluntary association;

(c) When a juvenile is married.

Section 5: Enforcement Procedures

(a) If a police officer reasonably believes that a juvenile is in a public place in violation of the Ordinance, the officer shall notify the juvenile that he or she is in violation of the Ordinance and shall require the juvenile to provide his or her name, address and telephone number and how to contact his/her parent or guardian. In determining the age of the juvenile and in the absence of convincing evidence such as a birth certificate, a police officer shall, in the first instance of violation of the Ordinance, use his or her best judgment in determining age.

(b) The police officer shall issue the juvenile a written warning that the juvenile is in violation of the Ordinance and order the juvenile to go promptly home. The Chief of Police shall send the parent or guardian of the juvenile written notice of the violation pursuant to subject (f).

(c) Police procedures shall constantly be refined in the light of experience and may provide that the police officer

may deliver to a parent or guardian thereof a juvenile under appropriate circumstances; for example, a juvenile of tender age, near home, whose identity and address may readily be ascertained or are known.

(d) Notwithstanding paragraph (b) of this Section, when: (1) a juvenile has received one previous written warning for violation of this Ordinance; or (2) a police officer has reasonable grounds to believe that the juvenile has engaged in delinquent conduct, the procedure shall then be to take the juvenile to the police station where a parent or guardian shall immediately be notified to come for the juvenile whereupon the parent or guardian and the juvenile shall be questioned. This is intended to permit ascertainment, under constitutional safeguards, of relevant facts, and to centralize responsibilities in the person designated there and then on duty for accurate, effective, fair, impartial and uniform enforcement, and recording, thus, making available experienced personnel and access to information and records.

(e) When a parent or guardian, immediately called, has come to take charge of the juvenile, and the appropriate information has been recorded, the juvenile shall be released to the custody of such parent or guardian. If the parent or guardian cannot be located or fails to take charge of the juvenile, then the juvenile shall be released to the juvenile authorities, except to the extent that in accordance with police regulations, approved in advance by juvenile authorities, the juvenile may temporarily be entrusted to an adult, neighbor or other person who will on behalf of a parent or guardian assume the responsibility of caring for the juvenile pending the availability or arrival of a parent or guardian.

(f) In the case of a first violation of the Ordinance by a juvenile, the Chief of Police shall by certified mail send to a parent or guardian written notice of the violation with a warning that any subsequent violation will result in full enforcement of the Ordinance, including enforcement of parental responsibility and of applicable penalties.

(g) For the first violation of the Ordinance by an operator of an establishment who permits a juvenile to remain on the premises, a police officer shall issue a written notice of the violation with a warning that any subsequent violation will result in full enforcement of the Ordinance, including enforcement of operator responsibility and of applicable penalties.

(h) In any event, the police officer shall within 24 hours, file a written report with the Chief of Police or shall participate to the extent of the information for which he or she is responsible in the preparation for a report on the curfew violation. It is not the intention of this Section to require extensive reports that will prevent police officers from

performing their primary police duties. The reports shall be as simple as is reasonably possible and may be completed by police departmental personnel other than sworn police officers.

#### Section 6: Penalties

(a) If, after the warning notice pursuant to Section 5 of a first violation by a juvenile, a parent violates Section 2 (in connection with second violation by the juvenile), this shall be treated as first offense by the parents. For the first offense by a parent, the fine shall be \$50.00, and for each subsequent offense by a parent the fine shall be increased by an additional \$20.00, e.g., \$70.00 for the second offense, \$90.00 for the third offense. The judge of the Family Court of the State of Delaware, upon finding a parent guilty, shall sentence the parent to pay this fine and the cost of persecution.

(b) The parent or legal guardian having custody of a juvenile subject to this Section shall be liable for all costs incurred by the Town for providing personnel to remain in the company of a juvenile who has been detained as a curfew violator if the parent or guardian does not pick up the juvenile within one hour after receiving notice from the Town that the Town is detaining the juvenile for a curfew violation. The amount to be paid by the parent or guardian shall be based on the hourly wage of the Town employee who is assigned to remain with the juvenile plus the cost of benefits for that employee.

(c) The parent or legal guardian having custody of a juvenile subject to this Section shall be liable for any fine or condition of restitution or reparation imposed by a court upon a curfew violation, provided that the curfew violator has not paid the fine or made restitution or reparation within the time order by the court, and further provided that the parent or legal guardian has been made a party defendant in all enforcement proceedings against the curfew violator and shall be served with all citations, summons, complaints, notices and other documents required to be served on the curfew violator defendant.

(d) Any juvenile who shall violate any of the provisions of the Ordinance more than three times shall be reported to the Chief of Police to the juvenile authorities as a juvenile in need of supervision and the Chief of Police may proceed to file such charges with the courts as he or she may deem appropriate.

(e) If, after warning notice pursuant to Section 5 of a violation of the Ordinance, an operator of an establishment violates Section 3 a second time, this shall be treated as a first offense by an operator, the fine shall be \$50.00 and for each subsequent offense by an operator the fine shall be increased by an additional \$20.00, e.g., \$70.00 for the second offense, \$90.00 for the third offense.

Section 7. This Ordinance shall become effective upon its adoption by a majority of the Commissioners of the Town of Bridgeville.
