

REGULAR MEETING
COMMISSIONERS OF BRIDGEVILLE
SEPTEMBER 12, 1994

MEETING WAS CALLED TO ORDER BY PRES. TULL WITH A SALUTE TO THE FLAG. ALL COMMISSIONERS WERE PRESENT.

GUESTS PRESENT WERE CHARLOTTE CANNON, CHIEF HANDLEY ORR, AND ALDERMAN ROBERT.

A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. HARDESTY TO DISPENSE WITH THE READING OF THE MINUTES AND APPROVE OF THE SAME. MOTION SO CARRIED.

BILLS IN THE AMOUNT OF \$20,458.89 WERE PRESENTED FOR PAYMENT. A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. TORBERT TO PAY THE BILLS AS PRESENTED. MOTION SO CARRIED.

PRES. TULL ASKED FOR DEPARTMENT REPORTS.

ALDERMAN REPORT: COPY ATTACHED

WATER DEPT- COMM. HARDESTY REPORTED THAT THE TOWN SUPPLIED 3,960,000. GALLONS OF WATER FOR THE MONTH OF AUGUST. ONE METER PIT WAS INSTALLED AND ONE LEAK ON CHURCH STREET WAS REPORTED AND REPAIRED. HE ALSO REPORTED THAT THE RECORDS MGT. PROGRAM WAS SLOW IN PROGRESS DUE TO A FAMILY ILLNESS WITH THE PERSON DOING THE RECORDS.. COMM. HARDESTY FELT THAT WORK ON THE PROJECT WOULD SOON BE RESUMED AND FINISHED. HE ALSO REPORTED THAT THE LAND ACQUISITION FROM THE DAVIS PROPERTY WAS COMPLETED AND THE DEED WAS BEING RECORDED BY OUR ATTORNEY.

STREET DEPT.-COMM. SIPPLE REPORTED THAT THE STREET ELECTRIC BILL FOR LAST MONTH WAS \$1,375.45. SHE STATED THAT SHE HAD TALKED TO SCHOOL OFFICIALS ABOUT A STORM DRAIN BEING PUT IN AT SCHOOL LANE AT THE SCHOOLS EXPENSE. SHE IS TO GET IN TOUCH WITH THEM IN THE NEXT THREE (3) WEEKS. COMM. HARDESTY SAID THAT HE AND DOUG JONES HAD FOUND THE BLUE PRINTS OF THE SEWER AND DRAINAGE LINES AND THAT A COPY OF THEM HAVE BEEN GIVEN TO SCHOOL OFFICIALS. COMM SIPPLE ALSO COMMENTED ON THE BEE REMOVAL AND THAT SHE FELT THAT THEY HAD BEEN TAKEN CARE OF.

SEWER DEPT.- COMM. SLATER STATED THAT THINGS AT THE PLANT WERE QUIET.

POLICE DEPT- COMM. TORBERT GAVE THAT REPORT-COPY ATTACHED. HE ALSO STATED THAT THE POLICE DEPT. WAS STILL WORKING ONE MAN SHORT AND THAT HE WOULD LIKE TO DISCUSS THAT IN EXECUTIVE SESSION.

PRES. TULL STATED THAT THE BIDS FOR THE WATER/SEWER PROJECT WOULD BE OPENED ON WED. SEPTEMBER 14, 1994 AT 2:00PM. THEY WILL ALSO BE MEETING WITH DELDOT AT THIS TIME TO SEE IF THEY ARE IN AGREEMENT WITH THE PLANS.

PRES. TULL STATED THAT HE HAD BEEN IN CONTACT WITH A GENTLEMEN ABOUT THE PROSPECT OF TYING INTO OUR SEWER LINES ABOUT 3.5 MILES SOUTH OF RT 13 & 404. THIS WOULD BE AT HIS EXPENSE. PRES. TULL TOLD THE GENTLEMEN THAT WE WOULD NEED A LETTER AND A MAP FO THE PROPOSED SITE BEFORE HE WOULD EVEN CONSIDER IT. THE TOWN HAS NOT RECEIVED ANYTHING YET.

COMM. HARDESTY SAID HE HAD BEEN IN CONTACT WITH DR. LEWIS FROM THE U.O.D. WHO WILL BE HOLDING A FORUM ON "GROWTH AND INFRASTRUCTURE POLICY FOR SUSSEX COUNTY" IN GEORGETOWN ON OCTOBER 7TH. COMMISSIONERS HARDESTY, SIPPLE, AND TORBERT WILL BE ATTENDING. COMM HARDESTY STATED THAT HE HAD ALSO SENT AWAY FOR SOME INFO ON COMPUTER SOFTWARE. HE HAS ALSO BEEN IN CONTACT WITH GENERAL CODE PUBLISHERS CORP OF ROCHESTER, N.Y. WHO WOULD COME IN AND LOOK AT OUR TOWN ORDINANCE BOOK AND GIVE US A PRICE ON ORGANIZING OUR ORDINANCES AT NO CHARGE FOR THE INITIAL CONSULTATION. COMM SLATER MADE A MOTION TO LET THEM COME DO A FREE CONSULTATION, MOTION SECONDED BY COMM. TORBERT.

CITIZENS PRIVILEGE- MRS. CHARLOTTE CANNON ASKED IF ANY CONTACT HAD BEEN MADE WITH DELDOT ABOUT THE TRUCK TRAFFIC COMING THRU BRIDGEVILLE. PRES. TULL RESPONDED THAT WE HAD NOT, BUT THAT WE WOULD ON WEDNESDAY DURING THE BID OPENING. IF THE BIDS ARE WITHIN THE MONEY GUIDELINES, CONSTRUCTION WOULD BEGIN HOPEFULLY THE SECOND WEEK OF OCTOBER. THEN ALL THE ROADS ON THE TOWN WOULD BE CLOSED TO ALL TRAFFIC EXCEPT TOWN RESIDENTS, SCHOOL BUSES, AND LOCAL DELIVERIES.

A MOTION WAS MADE BY COMM. SLATER AND SECONDED BY COMM. HARDESTY TO ENTER INTO EXECUTIVE SESSION TO DISCUSS PERSONNEL AT 7:30PM. MOTION SO CARRIED.

THE COMMISSIONER CAME OUT OF EXECUTIVE SESSION AT 9PM WITH THE DECISION TO PROMOTE CPL. SMITH TO SGT AND TO HIRE A NEW FULL TIME POLICE OFFICER BY THE NAME OF ROBERT MARTINE.
