

COMMISSIONER'S MEETING  
SEPTEMBER 14, 1992  
7:00 P. M.

MEETING CALLED TO ORDER BY PRESIDENT SLATER AT 7:00 P. M.

COMMISSIONER ROYAL LEAD THE PLEDGE OF ALLEGIANCE.

APPROVAL OF BILLS WAS TABLED UNTIL MRS. PUSEY COULD GET THEM IN ORDER.

MOTION MADE BY COMMISSIONER TORBERT TO DISPENSE WITH READING OF THE MINUTES. SECOND BY COMMISSIONER CROCKETT.

THE TOWN IS IN THE PROCESS OF PUTTING TOGETHER A PACKAGE FOR REFERENDUM TO PUT NEW SEWER AND WATER LINES IN TOWN. FROM THE RESIDENTS HOUSE TO WATER METER WILL BE THE PROPERTY OWNERS. THE TOWN WILL FURNISH THE NEW METERS. A PUBLIC HEARING WILL BE SCHEDULED FOR THE REASON TO INFORM THE PUBLIC OF THE EXACT EXTENT AND THE PROJECT OUTLINE.

HANS MEDSLARZ EXPLAINED WHAT KIND OF REACTION TAKES PLACE WHEN YOU HAVE LEAD GOOSENECK WITH WATER WITH A PH OF 5.5.

BARBARA CHAFFINCH RAISED THE QUESTION CONCERNING THE QUALITY OF WATER NOW AND WHAT IT WILL BE WHEN THE PROJECT IS COMPLETED.

BARBARA CHAFFINCH ALSO RAISES THE QUESTION OF NOTIFYING EACH INDIVIDUAL HOUSEHOLD WHEN A POTENTIAL PROBLEM EXISTS WITH THE WATER, AS WELL AS NOTIFYING THEM WHEN IT HAS BEEN CORRECTED.

HANS MEDSLARZ SAYS THE SEWER PLANT IS TRYING TO CORRECT THE HYDRAULICS WITHIN THE PLANT AND CORRECT THE LOADING IN THE FORM OF SEPTAGE AND/OR AMMONIA LOADING WHICH IS COMING IN AND CAUSING PROBLEMS FOR THE OPERATOR HERE.

THE TOWN HAS BEEN APPROACHED BY SEVERAL HOMEOWNERS TO EXTEND NEW SEWER LINES OUT DEL. 404.

THE TOWN IS ELIGIBLE FOR A GRANT FOR THE NEW WATER PROJECT THROUGH FARMERS HOME ADMINISTRATION.

A MOTION WAS MADE AND PASSED TO HOLD A REFERENDUM MEETING AT THE FIRE HALL ON MONDAY, OCTOBER 19, 1992 AT 7:30 P. M. REGARDING THE WATER AND SEWER ISSUES.

SINCE THE TOWN WILL BE SENDING OUT MORE LETTERS TO EACH HOUSEHOLD, A SUGGESTION WAS MADE BY MRS. CHAFFINCH TO APPLY FOR BULK RATE. ALSO, THE SENIOR CENTER HAS OFFERED TO DO ANY MAILING FOR THE TOWN.

A MOTION WAS MADE BY COMMISSIONER RIZZO FOR A TOWN COMPOST WHERE THE RESIDENTS OF THE TOWN CAN BRING THEIR LEAVES AND LIMB. THEN APPROXIMATELY ONCE A MONTH A SHREDDER WILL TURN THIS INTO MULCH THAT THE RESIDENT MAY GET ON A "FIRST COME, FIRST SERVE" BASIS.

COMMISSIONER ROYAL IS CONCERNED ABOUT THE ALLEYS. A DISCUSSION WAS HELD ABOUT WAYS TO CLEAN THEM.

LINDA KAPLA, OF THE APPLE SCRAPPLE FESTIVAL, REQUESTED THAT THE TOWN PROVIDE ELECTRICITY ON DELAWARE AVENUE TO GIVE ACCESS TO THE FOOD VENDORS. SHE ALSO REQUESTED THAT THE TOWN LOAN THEM THE MONEY TO PURCHASE T-SHIRTS AND HATS. THEY WILL REIMBURSE THEM AFTER THE FESTIVAL. APRONS WILL BE PROVIDED TO ALL APPLE PIE BAKERS. STREET CLOSURES WILL BE RAILROAD AVENUE, DELAWARE AVENUE, CANNON STREET AND UNION STREET ON FRIDAY. SATURDAY WILL BE PRIMARILY DELAWARE AVENUE TO WILLIAM AND FROM WILLIAMS TO MARKET. MOTION WAS MADE BY COMMISSIONER TORBERT AND SECOND BY COMMISSIONER RIZZO TO LOAN THE FESTIVAL \$2400.00. ALSO TO SEND LETTER TO THE RESIDENTS OF THE STREETS BLOCKED OFF.

HANDLEY ORR STATED THAT LISA ELLIOTT, TOWN CLERK, HAD RESIGNED AS OF SEPTEMBER 8th. THE TOWN HAD RECEIVED GRANT FOR \$10,000 FOR STORM WATER MANAGEMENT AND ALSO \$150,000 GRANT FROM STATE FOR PARKS AND RECREATION FOR LOCATION NOT YET DESIGNATED.

PETITION FROM SOUTHERN GRILL'S OWNER, MR. TENAFLOSS, FOR APPROVAL FOR WASTER HAULER WAS DISCUSSED. APPROVAL MADE BY MOTION BY COMMISSIONER RIZZO. SECOND BY COMMISSONER CROCKETT.

COMMISSIONER SLATER STATED THAT HE IS NO LONGER USING HIS MOBILE PHONE FOR TOWN BUSINESS. BARBARA CHAFFINCH INQUIRED INTO THE AMOUNT USED FOR PERSONAL BUSINESS AND HOW MUCH WAS CHARGED TO THE TOWN.COMMISSIONER SLATER HAS REIMBURSED THE TOWN FOR HIS PORTION OF THE CALLS. THIS WAS MET WITH SATISFACTION BY ALL THE COMMISSIONERS.

ANNETTE SMITH, OF THE SEAFORD LEADER, HAD A QUESTION CONCERNING THE CONDEMNED HOUSE WITH THE TOWN OF BRIDGEVILLE. HANDLEY ORR STATED THAT THERE WAS A STAY OF EXECUTION UNTIL THE 16TH OF SEPTEMBER.

HANDLEY ORR ALSO STATED TO MRS. CHAFFINCH'S QUESTION ABOUT THE DISREPAIR OF THE STREETS THAT THERE WILL BE APPROXIMATELY \$250,000 FOR STREET REPAIR NEXT SPRING.

MOTION TO ADJOURN WAS MADE BY COMMISSIONER TORBERT. SECOND BY COMMISSIONER RIZZO.

September 1, 1993


Meeting was called to order at 7 P.M. by President Slater.
