

COMMISSIONERS OF BRIDGEVILLE  
REGULAR MEETING  
OCTOBER 10, 1994

Pres. Tull called the regular meeting to order at 7:03 P.M. with a salute to the flag.

All Commissioners were in attendance.

Guests present were: Alderman Andy Robert, Police Chief Handley Orr, Mrs. Charlotte Cannon, Nieta Lippert Lewis and Betsy Farlow of the Leader.

A motion was made by Comm. Slater, seconded by Comm. Hardesty to dispense with the reading of last month's regular meeting and to also approve same. Motion so carried.

Bills in the amount of \$20,316.38 were presented for payment. A motion was made by Comm. Slater, seconded by Comm. Torbert to pay bills as presented. Motion so carried.

Pres. Tull gave an update report on the water/sewer project. Project bids were opened on Sept. 9th, 1994. Only one bid was received and it was 1.1 million dollars over our available funds. This one bid was rejected by the Commissioners. Our Town's engineer is doing another package to go out on bids in January of 1995. Pres. Tull said only additional Items that had been added has been considered for cuts if it becomes necessary. No cuts will be made to anything that was originally planned.

A meeting is scheduled with DelDot in regards to our project and the Bridgeville By-Pass on October 18th at the Bridgeville Fire House from 4-8 P.M. DelDot is also willing to meet with the Commissioners in Georgetown prior to the meeting on the 18th.

Pres. Tull informed everyone present that the Town was given a certificate from the Recycle of Delaware Sponsors for their recycling efforts.

The Sussex County Economic Development Council will hold a meeting on the Sussex County Corridor on Oct. 13th from 1-4 P.M. at the Laurel Fire House. It is hoped that that we can have someone from the Town attend.

Pres. Tull said that also Marcus Cable is holding an Open House from 4-6 P.M. on Oct. 26. There will be a ribbon cutting at 4 P.M. Please respond by Oct 17 if anyone plans to attend.

The Greater Chamber of Commerce of Seaford is having a dinner at the Seaford Golf & Country Club on Oct. 27th. Cost is \$15.00 per person. Please respond by Oct. 19th if interested in going.

There Are several proposed workshops to be held by the Dept. of Transportation in regards to noise and sidewalk policies. It will be held in Georgetown on Oct. 12th.

The Delaware League of Local Governments is offering for a fee of \$100 to test any employees who drive commercial vehicles. This offer was deferrred until the next meeting.

Pres. Tull then asked for Dept. reports:

Alderman Report given by Alderman Robert is attached.

Police Dept. - Comm. Torbert congratulated Sgt. Kevin Smith for being Top Cop again this past month. A copy of the police report is attached. Comm. Torbert asked the other Commissioners to think about the purchasing of a new police car, the last one was bought in 1991. A new car can be bought under a State bid for the price of \$16,000. This has be done by the 1st of Feb.-95 in order to get the vehicle under a State bid.

Sewer Dept. - Comm. Slater said everything was running smoothly at the Plant. He said he wanted to report that the Apple-Scrappling Festival was a success and he would like for the Town to send a thank-you to young Bob Hunsberger for cleaning the streets after the Festival with his street sweeper.

Street Dept. - Comm. Sipple had sent a letter to the owner of the Market Street Apts. about restoring Mill Street to its original state before it was torn up to install water lines to the apartments. The street had just been tarred and chipped prior to construction of the Apartments. It is now full of pot holes. Mrs. Sipple had D.P.L. install several new street lights on Delaware Ave. and replaced at various poles in other locations. She will see that other dim lights be replace if she is notified.

Water Dept. - Comm. Hardesty said 3,858,000 gals of water were supplied for the month of Sept. Two leaks were repaired. The leak on Cedar and Laws is from a faulty valve - hoping it will seal itself. If not it will have to be repaired. Another leak on Cherry Alley needs repairing. The bad leak on S. Main St. Will be repaired by Representative Ewing.

Mr. Hardesty said he had a letter from the Sussex County Conservation District who informed him that it was up to the Town to keep up the drainage ditch that runs down from the cemetary. Copy of letter is attached. We have an erosion problem from this ditch of about 100 ft. Comm. Slater said he would like our Town Engineer to take a look at it. Pres. Tull asked if the problem could be deferred until after our water/sewer project begins. Comm. Hardesty said he had no problem with that.

Comm. Hardesty had also heard from the General Code Publishers Corp. about compiling our ordinances and Charter into one concise book. Copies of letter will be given to each Commissioner for study and discussion at a later date.

Pres. Tull asked the Commissioner what their thoughts were on Trick or Treat night. A motion was made by Comm. Slater, seconded by Comm. Sipple that Trick or Treat night would be held on Monday, Oct. 31st. from 6-8 P.M. for 12 year olds and under. Motion so carried.

Citizen's Privilege - Mrs. Cannon said she hoped as many Commissioners that could would be in attendance at the DelDot workshop meeting on Oct. 18. She said Bridgeville will be rid of trucks except for local deliveries. There will be a traffic light on Rt. 404 in front of Richard Lewis's house and all truck traffic and a lot of the beach traffic will be rerouted pass her house to Rt. 13.

Pres. Tull thanked everyone for coming.

A motion was made by Comm. Hardesty to adjourn at 9 P.M., seconded by Comm. Slater. Motion so carried.


