

COMMISSIONERS OF BRIDGEVILLE  
REGULAR MEETING  
NOVEMBER 8, 1993

Meeting was called to order with a salute to the flag at 7 P.M.  
by President Tull.

Commissioners present: Stephen Cina, Charles Royal, Daryl Tull,  
Robert Slater and George Torbert.

Guests present: Carol Gaisor, Doug Jones, Chief Handley Orr and  
Alderman Andy Robert.

A motion was made by Comm. Slater, seconded by Comm. Torbert to  
dispense with the reading of last month's meeting minutes and  
approval of same. Motion so carried.

Motion was made by Comm. Slater, Seconded by Comm. Torbert to pay  
bills in the amount of \$17,952.74 as presented. Motion approved and  
so carried.

Pres. Tull read Ordinance #584-A - Increase in Court Costs - for the  
second reading of such Ordinance. This Ordinance will amend Ordinance  
#584. A motion was made by Comm. Cina to adopt Ordinance \$584-A in its  
entirety. Motion was seconded by Comm. Royal and unanimously approved.  
Pres. Tull said this would bring court cost up to the State's charges  
that are currently imposed.

A letter from Rev. Eugene Nesbitt, a member of the Bridgeville  
Community Action Corp. was read by Pres. Tull. They are requesting the  
use of and the leasing of the old police building for three years at  
\$1.00 per year. This would be used as a youth center. Pres. Tull  
said as everyone knows the building is for sale and just this past week  
someone had contacted him in regards to buying it and he would like to  
see this request tabled for the time being. There are several things  
to think about such as insurance, electric and heat. Who would pay  
these bills? Would the youths be just from the Town of Bridgeville or  
other places also? After discussion, Comm. Cina made a motion to table  
Community Action Corporation's request until further information is  
received from the Corporation and the Commissioners have more time to  
consider all areas of request. Motion was seconded by Comm. Royal.  
Motion approved and so carried.

Pres. Tull called for Department reports:

Alderman's Report - Report was given by Alderman Robert. Copy attached.

Police Dept. - Comm. Torbert gave his police report. Report attached.

Street Dept. - Comm. Slater said that alley and street work is going as  
scheduled. Should be finished by end of this week if weather is per-  
mitting.

Sewer Dept. - Comm. Royal said his report was waiting on outcome of the  
referendum. He wanted everyone to be aware of a cave-in on Delaware  
Ave. The location is now barricaded but he wondered if street could  
be totally blocked off. Chief Orr said this could not be done because  
of emergency vehicles. Comm. Cina asked if no parking signs could  
be put up on part of the street to eliminate possible traffic problems.  
Chief Orr will look into this in the morning.

No one is quite sure at this time what the problem is that has caused the cave-in. Doug Jones said larger equipment is going to be needed to repair whatever the problem is. Town employees are doing all they can to help keep cost down and save the Town money. Prices will be gotten on repairing whatever is wrong.

Water Dept. - Comm. Cina said he had no report since water bills did not go out until October 12.


General Dept. - Pres. Tull reminded everyone of the up-coming referendum on Monday, November 15, 1993. He asked everyone to please inform their neighbors and friends of the referendum and please ask them to vote in favor of it. Letters will be sent out and possible radio and T.V. spots will be used. Also an ad will be placed in the Delaware State News.

Pres. Tull said Rapa is pressing him for a letter allowing them to to drive a new well. He reminded the Commissioners that the initial proposal was for Rapa to use Town water exclusively and put in a 4" line. They are now using an existing 2" in line inside the building and saying it is meeting their needs. If they are using a 2" line now, Pres. Tull is afraid they will use this and put in their new well and not use our water at all. If they press us for the letter the Commissioners will hold a special meeting and vote on it.

Citizen's Report - Carol Gaisor, Town Librarian, said she wanted to thank the Commissioners for their continued support.

Motion was made by Comm. Slater, seconded by Stephen Cina to adjourn at 7:30 P.M.

ORDINANCE NO. 584-A

AN ORDINANCE TO AMEND ORDINANCE NO. 584 "AN ORDINANCE REGULATING THE ENFORCEMENT, ARREST, BAIL AND APPEAL PROCEDURES WITHIN THE CORPORATE LIMITS OF THE TOWN OF BRIDGEVILLE."

Be it ordained by the Commissioners of Bridgeville:

Section 584-709 MOTOR VEHICLE FINES PAYABLE BY MAIL.


(h) Court Costs and Applicability of Delaware Victim Compensation Law.

In lieu of any other court costs, and provided the offense is not subject to other proceedings under this ordinance, each fine for an offense under this ordinance shall be subject to court costs as provided for in Title 21 Motor Vehicle Fines Payable by Mail of the Delaware Code Annotated. Each fine for an offense under this ordinance shall be subject also to the penalty assessment which is or may be provided for in The Delaware Victim Compensation Law.
