CALL TO ORDER:

The meeting was called to order by President Harris.

QUORUM PRESENT:

President Harris reported that a quorum was present to conduct Town business.

PUBLIC COMMENT:

OPEN DISCUSSION:

WOODBIDGE LITTLE LEAGUE AND TOWN HALL EXPANSION PLANS

Town Manager DeBussy presented information received from GMB for Commissioner review. Commissioner Tomeski asked what funding would be used for either project; Town Hall expansion would require different funding than the Little League park area, but there are some options for both projects. Commissioner Tomeski requested a list of items that needed to be added to the infrastructure to start the building; the utility infrastructure is in place, but the amount of parking required is an issue. The building can be oriented to accommodate the little league and the infrastructure, but a new use agreement needs to be signed before any plans can proceed.

2025-2026 PROJECT OUTLINE/UPDATES

Information for the Community Reinvestment Funds was presented to the Commission. The Community Reinvestment Fund is a capital grant program that can be used for community redevelopment, revitalization and investment capital projects which will improve the economic, culture, historical, and recreational health of Delaware communities.

Commissioners are interested in participating in both programs.

EVENTS/EVENTS ORDINANCE REVIEW

Town Manager DeBussy reviewed the history of the Golf Tournament with the Commissioners to determine how to move the event forward. Commissioners discussed funds going towards the park project. President Harris requested two commissioners volunteer to create a board to assist Town Staff with the tournament; Commissioners Richards and Tomeski volunteered.

Commissioner Harris requested a review of the Events Ordinance. Commissioners discussed how events are classified, and what is required for “co-sponsored” events.

GRANT IN AID PROGRAM REVIEW

Town Manager DeBussy reviewed the Grant In Aid program, and the lack of organizations that have applied this year. Commissioners discussed advertising the program to more local organizations and updating the guidelines.

BOARD TRAININGS

Town Manager DeBussy announced the new attorney training would like to plan training for all town boards.
