The Project includes the following Work:

Installation of 8-inch water main, valves, reconnection of fire hydrants, new service lines to existing water meters, new service lines to existing residences, restoration, maintenance of traffic and other miscellaneous/ancillary related work as indicated within the contract documents on multiple streets within the Town. Work includes furnishing all equipment, material, and labor for the work described in the contract document drawings and specifications.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis.

The Project has an expected duration of 120 days.
